# CITY COUNCIL CITY OF WEST HOLLYWOOD MINUTES MONDAY, OCTOBER 7, 2002 WEST HOLLYWOOD PARK

CALL TO ORDER: Mayor Guarriello called the meeting to order at 6:46 P.M.

PLEDGE OF ALLEGIANCE: Yola Dore led the pledge.

#### REPORT OF CLOSED SESSION AGENDA:

City Attorney Jenkins stated that Closed Session convened at 6:00 PM. Council added one item to the Closed Session Agenda: one real estate acquisition regarding 9091 Santa Monica Blvd. He stated that the Closed Session recessed at 6:30 PM with no reportable action.

### **APPROVAL OF AGENDA:**

The City Manager requested to add an Urgency Item to the Agenda titled, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD REQUESTING ASSISTANCE FROM THE STATE ATTORNEY GENERAL'S OFFICE TO INVESTIGATE THE ATTACK AGAINST TREV BROUDY AS A HATE CRIME."

ACTION: Make the finding that the Item came to the attention of staff after the posting of the Agenda and that, there is an immediate need to hear the Item. Moved by Councilmember Heilman and seconded by Councilmember Prang to add the Item to the Consent Calendar as Item 2.BB. Motion carried unanimously.

Mayor Guarriello requested to add an Urgency Item to the Agenda titled, "A RESOLUTION CONCERNING DISTRICT ATTORNEY COOLEY'S FAILURE TO FILE THE HATE CRIME ENHANCEMENT IN THE CRIMINAL COMPLAINT AGAINST MESSRS. WALKER AND DOTSON."

Councilmember Prang and seconded by Mayor Pro Tempore Martin to add the Item to the Consent Calendar as Item 2.CC. Motion carried unanimously.

Councilmember Heilman requested that Items 2.Y. and 2.AA. be moved to Excluded Consent and noted his NO vote on Item 2.X.

Councilmember Duran requested that Items 2.L. and 2.O. be moved to Excluded Consent and noted his NO vote on Item 2.X.

ACTION: Moved by Mayor Guarriello and seconded by Councilmember Heilman to approve the October 7, 2002 Agenda as amended. Motion carried unanimously.

### PRESENTATIONS:

Mayor Guarriello presented a Resolution to the Breast Cancer Awareness Month Committee members and volunteers for the upcoming Breast Cancer Awareness Door to Door campaign proclaiming October as Breast Cancer Awareness Month. Councilmember Heilman also thanked the many co-sponsors for their support of Breast Cancer Awareness Month.

Councilmember Prang presented a Resolution to members of the Disabilities Advisory Board proclaiming October as "Disability Awareness Month" and October 16<sup>th</sup> as Disability Mentoring Day.

Councilmember Heilman presented a proclamation and flag to the West Hollywood Team, who will be participating in Gay Games VI, which will be held in Sydney, Australia on November 2<sup>nd</sup>-6<sup>th</sup>.

### **PUBLIC COMMENT:**

LEE BACA, SHERIFF OF LOS ANGELES COUNTY, thanked the City Council and members of the community who helped in the capture of the perpetrators who attacked Trev Broudy. Sheriff Baca stated that District Attorney Cooley not charging this as a hate crime is unacceptable. He stated that the Sheriff's Department will continue to fight the scourge of hate with all of its available resources.

SHEILA KUEHL, STATE SENATOR, stated that she wanted to show support for the City Council and for Sheriff Baca. She stated that she introduced two bills that would have made hate crime laws stronger. She expressed her disagreement with District Attorney Cooley and stated the importance for the community to continue to discuss the issue and to pressure the District Attorney's Office to add hate crime as one of the charges.

CAPTAIN LINDA CASTRO, LOS ANGELES SHERIFF'S DEPARTMENT, thanked the City and the community for their support. She also thanked the California Highway Patrol and Deputy Sheriffs from around the County, who helped in apprehending the suspects. She stated that over 1,000 hours have been spent on investigating this crime.

JAMES FUHRMAN, WEST HOLLYWOOD, spoke regarding Item 2.J., the attendance of Commission and Advisory Board members.

ED AHERN, WEST HOLLYWOOD, spoke regarding disabilities issues, specifically accessibility in the community gardens and announced the National Disability Mentoring project.

BOB DROLLINGER, WEST HOLLYWOOD, spoke regarding parking issues on Formosa and Detroit.

ALICIA DE SOTO FOLEY, WEST HOLLYWOOD, spoke in support of Item 2.AA. She also stated that she would like the Detroit Community Gardens to be replaced with properties that would not be dependent on the City of Los Angeles.

CASSANDRA RAMIREZ, LOS ANGELES, spoke in support of Item 2.L. She also stated that the community must continuing discussing hate crimes.

HILARY SELVIN, LOS ANGELES, read a letter from the West Hollywood Chamber of Commerce to District Attorney Cooley which requested him to reconsider his decision.

DAVE WALSH, WEST HOLLYWOOD, thanked the City Council and Sheriff's Department on behalf of Trev Broudy and his family.

TOM DEMILLE, WEST HOLLYWOOD, thanked participants of the Stamp Out the Hate Rally. He presented Captain Castro with a piece of art that he created specifically for her.

MARK OLSON, SOUTHERN CALIFORNIA EDISON, announced that the City of West Hollywood had no rolling blackouts during the summer. He thanked the City of West Hollywood for its conservation efforts.

KATHERINE THULIN, WEST HOLLYWOOD, stated that the City's nightlife contributes to hate crimes.

JIMMY PALMIERI, WEST HOLLYWOOD, thanked the City Council and the Sheriff's Department for their diligent work in capturing the hate crime suspects.

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke regarding hate crimes and provided suggestions for reducing crime.

JOYCE ROONEY, LOS ANGELES, spoke regarding WEHOME mediation and announced that management rejected the Union's offer. She stated that WEHOME has requested strike sanctions from the American Federation of Labor.

JIM KAZAKOS, WEST HOLLYWOOD, spoke regarding the Halloween Carnaval and requested that the City Council ask attendees to leave their pets at home.

ELODIE MCKEE, BURBANK, spoke regarding hate crimes and expressed her disagreement with District Attorney Cooley's decision.

ABBE LAND, WEST HOLLYWOOD, spoke in opposition to District Attorney Cooley's decision. She also spoke in support of Item 5.C.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in opposition to District Attorney Cooley's decision. She spoke in opposition to liquor licenses and also spoke in support of Item 5.C.

### **COUNCILMEMBER COMMENTS:**

Mayor Guarriello stated that as Mayor he will not allow hate crimes in the City. He announced that there is a recall of District Attorney Cooley and outlined the reasons. He read an excerpt from a letter that he received from Congressman Henry Waxman stating opposition to District Attorney Steve Cooley's decision.

Councilmember Duran commended Councilmember Heilman and staff on the success of the West Hollywood Book Fair. He stated that there was a communication error to the Planning Commission regarding using the St. Ambrose Church parking lot for

evening parking. He stated that his intention was to only look into using this one lot rather than all church lots in the city. He requested that the Planning Commission look

into using only the St. Ambrose Church parking lot for evening parking. He also announced that the City Manager has arranged a meeting with Attorney General Bill Lockyer regarding the hate crime, and that he will be the Council representative at the meeting.

Councilmember Prang thanked the Sheriff's Department and community for their support. He announced that members of the Los Angeles City Council will have a resolution supporting the City of West Hollywood on their stand against District Attorney Cooley's decision. He congratulated Metropolitan Community Church on the celebration of their 35<sup>th</sup> anniversary. He also suggested that attendees of the upcoming Halloween Carnaval leave their animals and young children at home.

Councilmember Heilman thanked Staff and the community for their support of the West Hollywood Book Fair. He announced a human rights speaker event on October 22<sup>nd</sup> titled, "Why I Oppose the Death Penalty" to be presented by Mike Farrell. He commended Sheriff Baca and the entire Sheriff's Department on their great work handling the recent hate crime.

Councilmember Martin thanked the Senior Advisory Board and Jackie Speier, for their help in kicking off the pharmacy sign program for seniors. He announced a press conference and rally on Wednesday at 10:00 AM in front of District Attorney Steve Cooley's office and a rally on Thursday starting in the City Hall parking lot and march to Matthew Shepherd Triangle. He requested that the meeting be adjourned in memory of Sheriff's Deputy Don Mueller's brother.

### **CITY MANAGER'S REPORT:**

City Manager Arevalo introduced Assistant Fire Chief Paul Schuster from Division 7 and Maria Grycan, the Community Services Rep, who will help in improving the Fire Department's community involvement.

City Manager Arevalo also provided an update on the negotiations with WEHOME. He stated that while mediation was not successful in signing an agreement, it was helpful in narrowing issues. He stated that he is disappointed that they were not able to reach agreement, but he believes that the package on the table is fair. He stated that he is aware that the union is considering a strike. He stated that the City has a plan in place in case the union votes to strike.

### FISCAL IMPACT ON CONSENT CALENDAR:

City Clerk Russell stated that the fiscal impact on the Consent Calendar, as amended, for the Monday, October 7, 2002 Agenda is \$3,900 in expenditures and \$3,500 in potential revenues.

- 3.B. PROPOSED EXPANSION OF PREFERENTIAL PARKING DISTRICT 9: City Clerk Russell stated that this item was posted at City Hall, Plummer Park, Sheriff's Station, West Hollywood Park and published in the West Hollywood Independent.

Donald Korotsky, Associate Transportation Planner, provided background information as outlined in the staff report dated October 7, 2002.

Mayor Guarriello opened the public hearing and the following speakers came forward:

KATHY LUBINSKY, WEST HOLLYWOOD, spoke in support of staff's recommendation.

ABBY PALANKER, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

HILLARY SELVIN, LOS ANGELES, spoke in opposition to staff's recommendation.

Mayor Guarriello closed the public hearing.

In response to Councilmember Heilman, Ms. Selvin stated that she has been meeting with the community regarding permit parking. She also

stated that she would like to meet with the City to look into further alternatives.

Councilmember Duran stated that the City has an increasing problem with parking and that it is the City's responsibility to explore alternatives to deal with parking issues, including working with the community on parking issues.

Councilmember Heilman stated that permit parking is what the neighborhood wants, which is evidenced by the signatures on the application.

### 5. NEW BUSINESS:

5.A. RESOLUTIONS REGARDING THE ADMINISTRATION OF THE GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, MARCH 4, 2003:

Tony Russell, City Clerk, provided background information as outlined in the staff report dated October 7, 2002. He announced that the City of Los Angeles requested consolidation with the City of West Hollywood's March 4, 2003 election for the Community College District and the Los Angeles Unified School District elections.

Councilmember Heilman suggested that Resolution No. 02-2786 be amended to automatically translate the Candidate Statements to Spanish and Russian and then placed into the voter's pamphlet at no cost to the candidates.

RECOMMENDATIONS: 1) Adopt Resolution No. 02-2784, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, CALLING AND GIVING NOTICE OF A GENERAL MUNICIPAL ELECTION TO BE HELD ON TUESDAY, MARCH 4, 2003 FOR THE ELECTION OF CERTAIN OFFICERS AS REQUIRED BY THE PROVISIONS OF THE LAWS OF THE STATE OF CALIFORNIA RELATING TO GENERAL LAW CITIES." 2) Adopt Resolution No 02-2785, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF LOS ANGELES TO RENDER

ACTION: Moved by Councilmember Heilman and seconded by Mayor Pro Tempore Martin to approve staff's recommendation with additional direction to amend Resolution No. 02-2786, Section 2 and Section 3, specifying that Candidate Statements be translated into Spanish and Russian and placed into voter's pamphlet at no cost to the candidates. Motion carried unanimously.

### 5.B. AN ORDINANCE REGARDING CONSUMER FINANCIAL INFORMATION PRIVACY:

Councilmember Prang provided background information as outlined in the staff report dated October 7, 2002.

Councilmember Heilman suggested that sending a resolution rather than an ordinance would be a more appropriate action for the City.

Councilmember Prang stated that the City of West Hollywood sent a resolution in support of this legislation, however, it was overshadowed by the banking industry lobby in Sacramento. He stated that a resolution would not have enough clout.

Councilmember Duran expressed his opposition to this item. He stated that this type of legislation is more appropriate for State government and that it would add another level of bureaucracy to the City. He stated that it would be difficult to enforce and investigate. He also stated that he was not aware of any local abuse by the banking industry. He suggested sending a letter of support to Senator Speier.

Mayor Pro Tempore Martin suggested drafting an ordinance that would become effective in January 2004 in order to review the State legislation.

RECOMMENDATION: Direct the City Attorney to draft a City ordinance regarding consumer financial information privacy.

ACTION: Moved by Councilmember Prang and seconded by Mayor Guarriello to direct the City Attorney to draft an ordinance that would

become effective in January 2004, pending the outcome of State legislation. Motion carried on a ROLL CALL VOTE.

## 5.C. A RESOLUTION AMENDING THE RULES OF CONDUCT OF CITY COUNCIL MEETINGS WITH REGARD TO EX- PARTE COMMUNICATIONS:

Councilmember Prang provided background information as outlined in the staff report dated October 7, 2002.

Councilmember Duran stated that the intention behind the item was good, but not practical because he would not be able to write down every

person he spoke to about an item. He stated that it would hamper his ability to decide on controversial items.

Councilmember Heilman stated that the proposed rules of ex parte communications are too strict.

Mayor Pro Tempore Martin stated that meeting with constituents is very helpful in making decisions on various issues.

City Attorney Jenkins stated that it would be unrealistic and impractical to expect the Councilmembers to remember every person with whom they have discussed issues. He stated that this item has a very narrow definition of ex parte communications. He stated that a Councilmember would only have to report something that has been said outside of a public hearing that influences his decision.

Councilmember Heilman requested that the Resolution be revised to clarify the definition of ex parte communications.

RECOMMENDATION: Adopt Resolution No. 02-2787, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD AMENDING THE RULES FOR THE CONDUCT OF CITY COUNCIL MEETINGS."

ACTION: Moved by Councilmember Heilman and seconded by Councilmember Duran to table the Item with direction to revise the resolution to clarify the definition of ex parte communications. Motion carried on a ROLL CALL VOTE.

AYES: Councilmember Duran, Heilman, Mayor Guarriello.
NOES: Councilmember Prang, Mayor Pro Tempore Martin.

### 5.D. ISSUANCE OF SPECIAL PARKING PERMITS FOR HOME VISITS BY SOCIAL SERVICE PROVIDERS:

Councilmember Prang provided background information as outlined in the staff report dated October 7, 2002.

Mayor Pro Tempore Martin stated his opposition of the item because it conflicts with the separation of church and state.

RECOMMENDATION: Direct Transportation staff and, if necessary the Transportation Commission, to develop criteria for the purpose of issuing special parking permits or other appropriate accommodations for social service providers, including members of the clergy, who conduct home counseling/service visits to ailing members of the community.

ACTION: Moved by Councilmember Prang and seconded by Councilmember Heilman to approve staff's recommendation. Motion carried on a ROLL CALL VOTE.

Guarriello.

NOES: Mayor Pro Tempore Martin.

### **EXCLUDED CONSENT CALENDAR:**

Councilmember Duran stated that he felt that the item was contradictory to Item 2.O.

Councilmember Prang suggested that this item could be passed with the added direction that the Public Facilities Commission review the project before Council approval.

CASSANDRA RAMIREZ, CITY OF LOS ANGELES, spoke in support of staff's recommendation for this item.

Councilmember Heilman stated his concern with the number of memorials in West Hollywood. He suggested that the Public Facilities Commission come up with alternatives to traditional memorials to honor all of the diverse communities in West Hollywood.

RECOMMENDATION: 1) Adopt Resolution No. 02-2774, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD IN SUPPORT OF NATIONAL TRANSGENDER DAY OF REMEMBRANCE, ON NOVEMBER 20, 2002." 2) Approve the concept of placing an appropriate transgender remembrance memorial in the Matthew Shepard Human Rights Triangle. 3) Direct staff to work with Lesbian and Gay Advisory Board, Transgender Task Force, Transgender Resource Center, Fine Arts Commission, and the community to develop an appropriate transgender remembrance memorial for future approval by City Council.

ACTION: Moved by Councilmember Prang and seconded by Councilmember Duran to approve staff's recommendation with direction that the Public Facilities Commission review this action for consistency with City policy.

### 2.O. MORATORIUM ON THE DEDICATION OF 'TRIBUTE' TREES AND PLAQUES:

Councilmember Duran stated that he pulled this item because he felt that it contradicted Item 2.L., and stated that after discussing Item 2.L., he is in support of staff's recommendation.

RECOMMENDATION: 1) Direct that a moratorium on the dedication of tribute trees and plaques be established, as well as other naming of public spaces, things, facilities, etc.; 2) Direct the Public Facilities Commission to draft and present to the City Council uniform criteria and policies regarding such dedications and tributes.

ACTION: Moved by Mayor Guarriello and seconded by Councilmember Duran to approve staff's recommendation. Motion carried unanimously.

2.U. ADOPTION OF JOB DESCRIPTION FOR NEW TEMPORARY POSITION OF LEGAL INTERN IN THE DEPARTMENT OF PUBLIC INFORMATION AND ADJUDICATION SERVICES:

ACTION: This item was tabled.

# 2.Y. A RESOLUTION OPPOSING THE REDUCING AMERICAN'S VULNERABILITY TO ECSTASY (RAVE) ACT, UNITED STATES SENATE BILL 2633:

Councilmember Heilman stated that he would like to review a copy of the bill before making any decisions. He expressed his concern about

comments in the resolution and staff report about legal terminology contained in the bill.

ACTION: Council concurred to table this Item.

# 2.AA. DIRECTION TO STAFF TO INVESTIGATE THE ABILITY OF THE CITY TO PURCHASE THE HAVENHURST COMMUNITY GARDENS LOT AND DEVELOP A NEIGHBORHOOD PARK ON THAT SITE:

Councilmember Heilman stated that this item should be discussed in closed session because it involves the acquisition of real property.

Councilmember Martin stated that it is not necessary to discuss this issue in closed session because many issues relating to acquiring property do not apply to this situation. He stated that the public has the right to hear it in open session.

Mayor Guarriello stated that he is concerned that this project is on the westside and that there are no greenspace projects on the eastside of West Hollywood.

Councilmember Prang stated that it is a policy issue and that land acquisition should be discussed in closed session. He stated that the funds designated for greenspace were originally set aside for acquisitions near Santa Monica Boulevard.

ACTION: Moved by Councilmember Heilman and seconded by Mayor Guarriello to table this item to the next Closed Session. Motion carried on a ROLL CALL VOTE.
