RECOMMENDATION: Continue this item to the August 19, 2002 City Council meeting.

ACTION: Moved by Councilmember Heilman and seconded by Councilmember Duran to approve staff's recommendation. Motion carried unanimously.

3.B. DEMOLITION PERMIT 2001-15 TO DEMOLISH TWO RESIDENTIAL STRUCTURES LOCATED AT 354 – 366 SHERBOURNE DRIVE, WEST HOLLYWOOD:

City Clerk Russell stated that this item was posted at City Hall, Plummer Park, Sheriff's Station, West Hollywood Library and published in the West Hollywood Independent.

John Keho, Senior Planner, provided background information as outlined in the staff report date July 15, 2002.

Mayor Guarriello opened the public hearing and the following speakers came forward:

ANNE MARIE ISLEIB, WEST HOLLYWOOD, appellant, stated that the Planning Commission approval of the demolition permit was not fair and/or impartial. She also stated that the demolition permit was never part of the Cedar's Sinai initial TUP application nor was it ever part of the appeal before City Council. She also stated that there is no justification for the demolition of the residential properties and demolishing these buildings will have a negative impact on the neighborhood.

JEFF HABER, LOS ANGELES, applicant, provided and overview of the demolition permit process. He stated that the demolition of the structures fulfills a public need by providing a landscape buffer between the parking lot and the residential area west of Sherbourne; it allows Cedars Sinai to continue to provide employee parking to replace the parking spaces lost due to the installation of the 15-foot buffer; and by demolishing these structures this will reduce loitering, trespassing and vandalism of the current structures.

JEFF HABER, LOS ANGELES, applicant, stated that the demolition permit is a discretionary act and he provided an overview of how the permit could be granted. He also stated that the Ellis Act under certain conditions would allow for demolition of certain properties.

ANN MARIE ISLEIB, WEST HOLLYWOOD, appellant, provided an overview of how the entire process went wrong. She also stated that there is no justification or public benefit for the demolition of these residential properties.

Mayor Guarriello closed the public hearing.

In response to Mayor Pro Tempore Martin, Mr. Jenkins stated that the code provides rules regarding demolition permits and how discretionary permits can proceed before a demolition permit is granted.

Councilmember Duran stated that the City can not compel the property owner to remain in the residential rental market. He also stated that the vacant boarded up buildings are urban blight. He stated that he would be in favor of the Planning Commission recommendation to demolish the structures and provide for the proposed landscaping plan.

Councilmember Heilman stated that the only matter before Council is the request to demolish the two buildings. He also stated that Council has worked with the neighborhood repeatedly on this project and has initiated the down zoning of the property. He stated that the two structures as they exist now only depreciate the value of the surrounding neighborhood. He stated that he would be in favor of demolishing the two structures and to work with the property owner on future development.

Councilmember Prang stated that Council has tried to be responsive to the neighborhood concerning various issues regarding this property. He also stated that the process regarding the demolition permits has been flawed and was not in the best interest of the public. He stated that he is looking for a long-term use of the property not a short-term use. He suggested that Council remand this item back to the Planning Commission and allow the residents and Cedars Sinai to work out their differences.

Mayor Pro Tempore Martin stated that he would oppose sending the issue back to the Planning Commission. He stated that it was unfortunate that 12 years ago the City didn't look at the property in its entirety and require Cedars to provide for a long-term use of the property. He stated that the TUP is not the right mechanism to use to demolish the two structures. He stated that the neighborhood and Cedars should be able to find a workable long-term solution for this property.

Mayor Guarriello stated that the lot has been a problem for the City for many years. He stated that since Cedars Sinai has owned the property they have not been a good neighbor to the City or to the residents of this area.

RECOMMENDATION: Adopt Resolution No. 02-2739, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD, DENYING THE APPEAL OF ANN MARIE ISLEIB AND UPHOLDING THE PLANNING COMMISSION'S CONDITIONAL APPROVAL OF DEMOLITION PERMIT 2001-15 ON AN APPLICATION BY CEDARSSINAI MEDICAL CENTER, LOCATED AT 354-366 SHERBOURNE DRIVE, WEST HOLLYWOOD."

RECOMMENDATION: Concur with staff finding that Club 7969 has complied with the terms of the agreement thereby allowing the Club to resume regular operations, which is up to seven (7) nights a week.

ACTION: Moved by Councilmember Heilman seconded by Mayor Guarriello to approve staff's recommendation. Motion carried unanimously.

4.B. HOLLOWAY PARK AND VETERANS MEMORIAL PROJECT:

Sam Baxter, Facilities and Landscape Manager, provided background information as outlined in the staff report dated July 15, 2002.

In response to Mayor Guarriello, Mr. Baxter stated that the overall cost of the project as presented is \$85,000.

TOM DEMILLE, WEST HOLLYWOOD, spoke in opposition to staff's recommendation.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of staff's recommendation.

Councilmember Heilman stated that he would like to see the flags moved to a more focal point of the project. He also stated that the project should include for the infrastructure for a future water feature.

RECOMMENDATION: 1) Approve a re-design of the Holloway Park and Veterans Memorial project as described in the staff report; 2) Authorize staff to solicit bids for constructing the Holloway Park and Veterans Memorial project as redesigned with a base bid and prioritize add alternatives as described in the staff report; and 3) Approve an Amendment to the existing contract with Campbell and Campbell Architects – Planners Landscape Architects of Santa Monica, California in an amount not-to-exceed \$20,000, for redesigning the Holloway Park and Veterans Memorial project as described in the staff report, and authorize the City Manager to sign.

Mayor Pro Tempore Martin stated that the West Hollywood Independent has been the paper of news for the City of West Hollywood for the past 10 years. He stated that the it is worth the cost for publishing notices to make sure the residents of the City are informed.

Councilmember Duran stated he would like to see what state law requires when it comes to publishing legal notices and what is discretionary or optional. He also stated that he would be in favor of the idea of making the notices more reader friendly.

Councilmember Prang stated that the City should continue to publish notices in either the West Hollywood Independent or the Beverly Press but also look at other over avenues to keep the public informed. He stated that the City should try to make the notices request a more understandable to the general public.

Mayor Guarriello stated that Council is trying to look at other efficient ways to expand the notification of hearings to residents.

Councilmember Heilman stated the residents have raised some legitimate concerns regarding the project. He stated that he would be in favor of an entrance and exit along Santa Monica Boulevard. He also suggested looking into enclosing the parking lot and look at the possible impact of a high water table in the area. He also stated that he would like to see the overall height of the project along Santa Monica Boulevard lowered.

Councilmember Prang stated the project is still too large for the site. He stated that he is not in favor of the size and mass for the project area.

Councilmember Duran stated that ingress and egress should be moved to the Santa Monica Boulevard side. He expressed his concerns with the size and mass along the Santa Monica Boulevard.

Mayor Pro Tempore Martin stated that he felt the project as proposed would not provide enough parking for the commercial residents. He stated that the size and mass of the project is too large for the proposed site.

RECOMMENDATION: Direct staff to draft an agreement with CIM Group to develop a mixed-use project including approximately 13,000 square feet of retail/restaurant use, public parking, 32 market-rate condominium units and 27 affordable rental units at the City-owned property at the northwest cornet of Santa Monica Boulevard and Hancock Avenue and return to City Council for its approval.

ACTION: Moved by Councilmember Heilman seconded by Mayor Guarriello to direct staff to re-design the proposed project with a substantial reduction in the height and density of the entire project, a reduction in height of the overall project, which faces both the Santa Monica Boulevard and Hancock Avenue and to explore ingress and egress of the parking structure on the Santa Monica Boulevard side. Staff was also directed to reduce the housing units for the proposed project to no more than 40 housing units. Motion carried unanimously.

He also stated he would like to get the opinion of the City of Los Angeles City Attorney regarding the reasons for their city's passage of such an ordinance.

Councilmember Prang stated that he would be in favor of staff's recommendation and would like the City Attorney to look at all the possible issues regarding such an ordinance.

Mayor Pro Tempore Martin stated that he would be in favor of drafting an ordinance, but had reservations that the City could enforce such an ordinance on Section 8 housing.

Councilmember Duran commented that he had serious concerns if the City could enforce a landlord to remain in a Section 8 housing contract.

RECOMMENDATION: Direct the City Attorney to draft an ordinance amending the Rent Stabilization Ordinance to prohibit a landlord, upon terminating or failing to renew a Section 8 contract, from charging rent in excess of the amount of the tenant's portion of the rent under the Rental Assistance Contract.

ACTION: Moved by Councilmember Prang seconded by Mayor Pro Tempore Martin to approve staff's recommendation. Motion carried unanimously.

5.A. ZONING CODE AMENDMENTS WITH REGARD TO BILLBOARDS IN THE REDEVELOPMENT AREA:

RECOMMENDATION: 1) Direct the Community Development and Redevelopment staff to draft a zoning code amendment, which allows replacement of billboards in conjunction with development in the Redevelopment area and at gateways to the City; 2) Direct staff to return to Council with a status report in 90 days; and 3) Direct staff to solicit input from the Project Area Committee and Planning Commission.

ACTION: Moved by Councilmember Heilman seconded by Mayor Guarriello to approve staff's recommendation. Motion carried with Mayor Pro Tempore Martin ABSTAINING.
