CALL TO ORDER: Mayor Land called the meeting to order at 7:13 p.m.

APPROVAL OF AGENDA: ACTION: Approve the agenda. Motion Schulte second Heilman. Hearing no objection it was so ordered.

- 1. CITY MANAGER'S REPORT: This time has been set aside for the City Manager to report to the City Council on any or all matters of importance. There was no report.
- 2. POSTING OF AGENDA: The agenda for the meeting of November 13, 1989, was posted at City Hall, Plummer Park, the West Hollywood Library and the Sheriff's Station on Wednesday, November 8, 1989.
 ACTION: Receive and file.
- 3. CANVASS OF THE ELECTION: ACTION: To Approve and adopt Resolution No. 611, "A RESOLUTION OF THE CITY OF WEST HOLLYWOOD, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION HELD ON NOVEMBER 7, 1989, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW." Motion Heilman second Schulte. Hearing no objection it was so ordered.

PUBLIC HEARINGS

4. ASHKENAZY HEARINGS - PUBLIC HEARING ON REQUEST FOR APPEAL OF THE PLANNING COMMISSION'S DECISION REGARDING THE GRANTING AND MODIFICATION OF CONDITIONAL USE PERMITS 89-06, 89-07, 89-08, 89-09, 89-11, 89-12 AND DENIAL OF CUP 89-10: Mayor Land announced that the procedure for this hearing would be to give the appellant 25 minutes and also allow Jeanne Dobrin, who wished to appeal but filed late, 25

minutes, and allow individual speakers 5 minutes. A letter from Ms. Dobrin to the City Attorney was accepted for the record. Mark Winogrond, Director of Community Development, reported that this public hearing consists of the appeals from the decisions of the Planning Commission of Sept. 7, 1989 relative to the Conditional Use Permit applications for the following hotels: Le Bel Age, Mondrian, Le Dufy, Valadon, Le Parc, Le Reve, and Cezanne.

On advice of the City Attorney, Councilmember Koretz declared a potential conflict of interest on the Valadon appeal, due to the fact that he lives within 300 feet of the hotel.

The City Attorney reported that there are some differences between the recommendations of the Planning Commission and the recommendations of staff. outlined He then differences in the new Resolutions that were distributed tonight and the Resolutions from last week. In regard to the Le Dufy, there was a reference to two garage entrances fact there is only one, and that correction was made. addition, there are several provisions in the County's Conditional Use Permit that are inconsistent with the City proposal and are being deleted. On the Cezanne, there are no substantive changes. On Le Parc, again there were 2 provisions in the County CUP that are inconsistent and are being deleted. On Le Reve and Valadon and Mondrian, no On Le Bel Age, a language change substantive changes. paragraph 5B describing the history on the 9th development and there are 2 provisions in the County CUP, again referring to charging for parking, that inconsistent and are being deleted. Conditions of approval were re-worded to clarify uses of roof-top areas and conference rooms. The 99 year time limit has been removed from the Mondrian and Le Bel Age.

The Deputy City Clerk, Vivian Vukojevich, reported that this hearing was noticed by display ad in the Post Newspaper on October 26 and a legal ad on November 2. Notices were posted at the 3 required places plus at City Hall.

At this point in time Mayor Land opened the public hearing and the following came forward to speak for the appellant:

Tom Winfield, Attorney for applicants for CUP's Lee Cohen, Attorney for owners of Valadon Hotel.

As stated earlier, equal time was then given to Jeanne Dobrin, West Hollywood resident, who spoke against various aspects of the agreements.

Mr. Winfield spoke in rebuttal and answered questions from the Councilmembers.

Jeanne Dobrin spoke in rebuttal.

Mayor Land called a recess at 9:53 p.m. The Council reconvened at 10:03 p.m.

Mayor Land closed the public hearing. City Attorney Jenkins addressed comments to the Council, followed by Council discussion.

ACTION: All hotels except Valadon - add the following conditions:

- 1) Ambient music be prohibited past the property line.
- Prohibit flags on the rooftops.
- 3) Change "guest" to "registered guest" in the appropriate

places.

- 4) Limit roof-top activities to not more than 50 people, no more than one a month, with a time limit of 8:00 p.m., with this condition to be reviewed in one year.
- 5) Trash bin at the Mondrian be removed and replaced with an appropriate recepticle, per the Community Development Director's approval.
- 6) Have a one year monitoring report direct to the City Council to determine if review or change of any conditions is necessary.
- 7) Restrict delivery from 8:00 a.m. to 5:00 p.m. and applicant is to use best efforts to restrict deliveries to small trucks and that they consider some sort of van pool arrangement.
- 8) If permit parking is not in effect in the area around the hotel, the parking must be free to guests.
- 9) No idling of buses be allowed. Buses to be allowed to load and unload only, but not after 10:00 p.m. They are not allowed to park on adjacent streets and the applicant shall submit a circulation plan for buses, delivery trucks, and all other vehicles, to the satisfaction of the Director of Community Development.

COUNCILMEMBERS COMMENTS: This time has been set aside for the Councilmembers to direct comments to staff and/or public on any and all matters of interest.

Councilmember Schulte asked that Council be informed on who are members of the Homeless Committee.

ACTION: Place support of the Schindler House on the agenda as an urgency item that came up after the required 72 hour posting. Motion Schulte second Heilman. Noting that there

were all ayes, the motion carried.

MOTION: Authorize staff to develop a letter, to be signed by the Mayor, showing the Council support to urge the Board of Equalization to regard Friends of Schindler House as a tax-exempt organization. Motion Schulte second Koretz.

ALTERNATIVE MOTION: Authorize staff to draft a letter in consultation with Councilmember Schulte, the Mayor and the City Attorney, to be signed by all interested Councilmembers. Motion Heilman second Schulte. Hearing no objection it was so ordered.

Mayor Land reported that the pro-choice rally at Rancho Park was a huge success. She also requested that staff explore the possibility of making the pool a year-round pool - staffing, money, etc, and also the possibility of the swim team being able to use the pool on Tuesdays and Thursdays.

LEGISLATIVE

5. ORDINANCE REGULATING PARKING OF BUSES: Direction was given to the City Attorney to make changes as discussed earlier and bring back to the Council meeting on Monday night for introduction on first reading.

ADJOURNMENT The meeting was adjourned at 12:30 a.m. to a regular adjourned meeting on November 20, 1989 at 7:00 p.m. at West Hollywood Park Auditorium.
