Sunset Strip Business Improvement District Security Ambassador's Report - December 2015

• 13 Total Calls for Service

- Five calls from businesses in regards to intoxicated individuals causing a disturbance. The Security Ambassadors were able to get each individual to leave without needing to call the Sheriff's Department.
- Security Ambassadors responded to two calls from businesses in regards to individuals refusing to leave the property. In both instances, the individual was intoxicated and unable to care for themselves. Paramedics were called out and transported the individuals to the hospital.
- Two requests were received for assistance with crowd control during the let out times for the business.
- There were four calls received in regards to homeless individuals causing a disturbance. One was smoking inside
 the restroom, two were panhandling and one was loitering on private property. All individuals complied with the
 Security Ambassadors' requests to move along.

• 141 Total Ambassador Services

- The Security Ambassadors assisted five separated individuals who were intoxicated, lost and by themselves. Two
 were male and three were female. The individuals were found passed out on the public sidewalk or stumbling
 into vehicle traffic. All five individuals were relocated with their friends who took care of getting them home.
- While on routine patrol the Security Ambassadors observed a homeless man instigating a fight with several individuals who were leaving a club. Ambassadors were able to persuade him to move along.
- While providing traffic and crowd control during a club let out, Security Ambassadors heard a traffic collision and saw the at fault party driving away. The driver finally stopped at the next red light, where the Ambassadors spoke to the driver and were able to get him to stand by until LASD Deputies arrived on scene.
- Security Ambassadors contacted nineteen homeless individuals while on patrol. Contact with these individuals
 was due to them sleeping on private property, panhandling, loitering inside a business and/or harassing
 pedestrians. The Ambassadors always treat each individual with respect and provide PATH information.
- While on patrol, the Security Ambassadors intervened in between four altercations and were able to separate the involved parties before it escalated into a physical fight.
- There were two fights in which the Security Ambassadors attempted to deescalate. One involved an individual refusing to leave a music venue. LASD Deputies were called out and the man was arrested. The other fight involved two groups of four and five individuals. Security Ambassadors utilized their flashlights and gave verbal commands to stop fighting. The fight lasted approximately two minutes and no injuries were reported.
