**CALL TO ORDER:** Mayor Prang called the meeting to order at 7:28 PM.

**PLEDGE OF ALLEGIANCE:** Fire Chief Jerry Vandenburg led the Pledge.

**ROLL CALL:**

**PRESENT:** Councilmembers Guarriello, Heilman, Martin, and Mayor Prang.

**ABSENT:** None.

**ALSO PRESENT:** City Attorney Jenkins, Acting City Manager Reynolds, Interim City Clerk Love, Assistant City Clerk Taylor, and Administrative Staff Assistant Bursztin.

**REPORT ON SANTA MONICA BOULEVARD REHABILITATION PROJECT:** City Engineer Perlstein provided an update on the Santa Monica Boulevard Rehabilitation Project including the upcoming Holiday Moratorium.

Mayor Prang spoke about the timeline for Hancock Construction.

**APPROVAL OF AGENDA:**

Councilmember Guarriello pulled Item 2.J. for separate discussion.

Mayor Prang and Councilmember Guarriello noted their ABSENTION on Item 2.H.

**ACTION:** Approve the December 4, 2000 Agenda as amended. **Motion Councilmember Guarriello, seconded by Councilmember Heilman and unanimously carried.**

IVY BOTTINI, WEST HOLLYWOOD, spoke in support of the Condom Initiative.

RIC RICKLES, WEST HOLLYWOOD, spoke about rent control and the housing needs of Seniors.

TERRY MORGAN, WEST HOLLYWOOD, spoke in opposition of the Condom Initiative.

DON BRUHNKE, WEST HOLLYWOOD, spoke about two Councilmembers abstaining from the Condom Initiative Item.

**COUNCILMEMBER COMMENTS:**

Councilmember Guarriello spoke about registered voters and the upcoming March 2001 Election.

City Attorney Jenkins clarified that two (2) members of the Council have abstained from voting on Item 2.H. Resolution opposing the Condom Initiative, which means that for approval of this item it would require at least two (2) votes, which in this case would constitute a majority.

Councilmember Martin spoke about the illegal work being done on the weekends. He spoke about recent expansions of Code Compliance efforts. He spoke in support of the Housing Study Session and requested that an agenda be done in the future. He discussed the impact of Costa-Hawkins.

Mayor Prang requested to adjourn the meeting in memory of Marty Abbitt, Harry Tanaka and Carolyn Aganos. He asked Councilmember Heilman to serve as Acting Mayor Pro Tempore at City Council Meetings. Mayor Prang acknowledged the new battalion Chief Jerry Vandenburg. He spoke about the Gay and Lesbian Advisory Board holding a town meeting to discuss the presidential election and thanked Deanna Stevenson for her help with this event. Mayor Prang thanked the Social Services staff for their work on World AIDS Day. He also addressed code violations that occur on the weekend. He spoke about abstaining on the Condom Initiative.

Acting Mayor Pro Tempore Heilman spoke in opposition of the Condom Initiative. He stated that the mandatory nature of the initiative is what troubles him. He felt that the focus should be on the unsafe behavior and not on the establishments.

**CITY MANAGER'S REPORT:** Acting City Manager Reynolds reported on a hazardous material incident at the West Hollywood Park Pool that has been resolved.

**FISCAL IMPACT ON CONSENT CALENDAR:** Assistant City Clerk Taylor stated the fiscal impact on the Consent Calendar of December 4, 2000 is \$187,335 in expenditures.

Tim Foy, Senior Planner, provided background information as outlined in the staff report dated December 4, 2000.

No further speakers coming forward, Mayor Prang closed the Public Hearing.

Councilmember Guarriello spoke in support of the appeal.

Councilmember Martin spoke in opposition of the appeal. He stated that if the project was to go forward, it would require a great deal of restrictions. He expressed concern over student parking problems. He spoke about relocating the bus stop outside the school. He spoke about the expansion and how it would work for this site.

Acting Mayor Pro Tempore Heilman spoke about the resentment that arises due to concerns not being addressed. He spoke about possible delay of the project so that the school could meet with the neighbors and address their concerns for a win-win solution. He stated the condition of the number of students to be enrolled in the school as well as the jogging along the streets. He spoke about the developer attempting to reduce the windows and it has that prison-like structure. He suggested garbage clean up and that kids will be kids. He stated that additional supervision

would be necessary. He suggested sitting the building back further and reducing the building to three (3) stories.

Mayor Prang stated that a high quality of school is an asset to the community. He stated that he was totally unprepared for the volume of residents who came out to speak against the development. He stated that the developer did not do its job and the school needs to be part of the neighborhood. He stated that some of the issues could have been dealt with early on such as traffic and noise. He stated that the General Plan allows for such development and it is within the rules but the school must work with the neighbors.

**ACTION:** 1) Defer a decision on this item for two (2) months; and, 2) Direct staff to start community mediation consisting of the architect and five (5) citizens from the neighborhood. **Motion Acting Mayor Pro Tempore Heilman, seconded by Councilmember Guarriello and unanimously carried.**

The City Council took a break at 9:58 PM.

**3.B. APPEAL OF PLANNING COMMISSION DENIAL CREATIVE SIGN PERMIT 2000-04, HOLLYWOOD STOCK EXCHANGE, 8441 SANTA MONICA BOULEVARD:**

John Chase, Urban Designer, provided background information as outlined in the staff report dated December 4, 2000.

Acting Mayor Pro Tempore Heilman asked how the current sign was approved.

Mayor Prang opened the Public Hearing and the following persons addressed the City Council:

TOM PAVICH, WEST HOLLYWOOD, spoke in support with the staff's alternative of limiting the lighting hours of operation of the sign. He suggested no inverse coloring of the lighting of the sign.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in opposition of the appeal.

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke in opposition of the appeal.



RALPH GENTILE, LOS ANGELES, Representative for the Applicant, spoke in support of the appeal.

Councilmember Guarriello spoke about the sign ceasing from inverse flashing at 10 PM.

No further speakers coming forward, Mayor Prang closed the Public Hearing.

Acting Mayor Pro Tempore Heilman spoke about the previous compromise over the size of the sign. He stated that he feels that the sign is unattractive and is a potential traffic danger. He spoke in opposition of the appeal.

Acting City Manager Reynolds provided background information as outlined in the staff report dated December 4, 2000.

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke about a previous survey that indicated the current site or near the park was most desirable.

STEVE ROSE, WEST HOLLYWOOD, spoke in opposition of placing the library at the Hancock site.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of the present location for the Library.

Councilmember Guarriello asked for additional sites.

Acting Mayor Pro Tempore Heilman spoke about the library being on the eastside and that there is a library on Gardener. He stated that he is not supportive of the Hancock location. He spoke about locating the Library along San Vicente Boulevard. He stated that there has to be ready access for those to utilize the Library. He stated that additional research should be done on Recommendations No. 2 and 3.

Councilmember Martin spoke in support of the Santa Monica Boulevard site with pedestrian orientation. He spoke about parking problems with the Library being built in West Hollywood Park and indicated that it should be incorporated into the City's Park Master Plan. Councilmember Martin also spoke about the financing of the project.

Mayor Prang agreed with Acting Mayor Pro Tempore Heilman's comments.

**ACTION:** 1) Continue further negotiations of space at West Hollywood Park and the Pacific Design Center (Sites 2 and 3) of the staff report; and, 2) Proceed with incorporating this project into the City's Parks Master Plan. **Motion Acting Mayor Pro Tempore Heilman, seconded by Councilmember Guarriello and unanimously carried.**

**ACTION:** Approve Alternative No. one (1) of the staff report and direct staff to amend the Business License Ordinance to include the automatic review of regulatory business licenses by the Business License Commission under the following circumstances:

1) After the issuance of the third administrative citation for any violation(s) observed on at least two separate dates within any six-month period; 2) After the issuance of the third administrative citation for the any violation(s) observed on at least three separate dates within any twelve-month period; and, 3) After formal notification by any law enforcement agency of a pattern of alleged criminal activity taking place at, or directly attributable to, a regulatory business license. **Motion Acting Mayor Pro Tempore Heilman, seconded by Councilmember Martin and unanimously carried.**

Councilmember Guarriello spoke about the Bylaws and Commission member attendance.

The Council discussed the size of the Advisory Board and gave direction to the Board to return with recommendations as to the size.

Acting Mayor Pro Tempore Heilman stated that if the Council decided to appoint someone that the Council should wait until after the deadline for submitting nomination papers. He indicated his support of appointing someone and suggested soliciting interest.

Councilmember Guarriello stated he wanted to wait until the election.

Mayor Prang spoke about appointing someone but not someone who is running in the upcoming election. He sees this as a great opportunity to participate in local government. He agreed with Acting Mayor Pro Tempore Heilman's comments on soliciting interest.

JOHN PAUL DRAYER, WEST HOLLYWOOD, spoke about the upcoming March 2001 Election and representation of the residents.

JEANNE DOBRIN, WEST HOLLYWOOD, spoke in support of John Paul Drayer's comments.

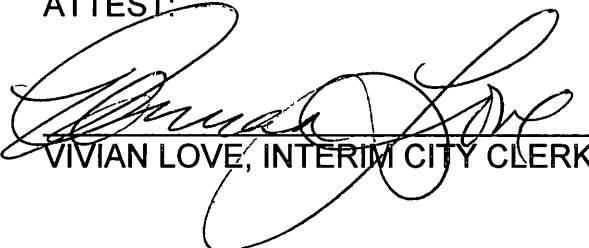
**CITY ATTORNEY REPORT OF CLOSED SESSION:** City Attorney Jenkins reported that no reportable actions taken.
