Council may then elect from the following alternatives: 1) make an appointment to fill the vacant Council position and direct the City Clerk to administer the Oath of Office; 2) select from among the applicants a group of finalists and defer making an appointment until Council members have had a further opportunity should they wish to interview the finalists one-on-one; or 3) defer making an appointment until Council members have had a further opportunity should they wish to interview any or all of the applicants one-on-one. If the Council selects alternatives 2 or 3, this meeting should be adjourned to May 13 at 6:30 p.m. at which time the Council will consider making an appointment.
