MAYOR COMMENTS:

Mayor Land spoke regarding the recent passing of Councilmember Sal Guarriello, and spoke regarding Councilmember Guarriello's commitment, dedication, and service to the City. She spoke regarding the recent West Hollywood Kid's Fair and Councilmember Guarriello's love for children and attendance at previous Kid's Fairs. She spoke regarding the need for the City to come together as a family during this difficult time.

Mayor Land spoke regarding the upcoming 25th Anniversary Capital Campaign and upcoming celebrations in the City. She emphasized that West Hollywood continues to be a city where people matter, with a strong emphasis on civil and human rights, affordable housing, gun control, LGBT issues, women's issues, and social services. She spoke regarding the need for the City to pause and reflect on the past 25 years, and the need for the city to continue to grow and change. She spoke regarding the values that the City outlined in its Vision 2020.

She spoke regarding upcoming conservation efforts by the City's Environmental Task Force. She spoke regarding ongoing advocacy efforts to have the Los Angeles Metro Red Line go through West Hollywood. She spoke regarding the upcoming fitness programs in the City, including the unveiling of the 3rd Well West Hollywood Walking Trail, and efforts to secure equal health benefits for the LGBT community.

She thanked the City Manager and City staff for their hard work and dedication. She thanked her fellow City Councilmembers for their idealism, creativity and innovation. She thanked the residents for the support they give to the City Council and to the community.
