THE APPLICANT FAILS TO ENSURE THAT A COPY OF THIS APPROVED PERMIT IS ON FILE WITH THE WATCH SERGEANT AT THE WEST HOLLYWOOD SHERIFF'S STATION (720 SAN VICENTE BLVD)

FAILING TO DISPLAY AND/OR PRESENT THIS PERMIT ON DEMAND TO ANY CITY INSPECTOR, CODE COMPLIANCE OFFICER, OR LAW ENFORCEMENT OFFICER ON DEMAND DURING CONSTRUCTION ACTIVITIES.

FAILING TO MITIGATE VALID NOISE COMPLAINTS TO THE SATISFACTION OF THE INVESTIGATING CITY INSPECTOR, CODE COMPLIANCE OFFICER, OR LAW ENFORCEMENT OFFICER.

ANY CONDITION THAT AN INVESTIGATING CITY INSPECTOR, CODE COMPLIANCE OFFICER, OR LAW ENFORCEMENT OFFICER OBSERVES AND DETERMINES TO POSE AN INJURIOUS CONDITION TOT HE PUBLIC'S HEALTH, SAFETY, OR GENERAL WELFARE.
