The staff Bicycle Planning Ad Hoc Committee is scheduled to meet with Navin Narang, Founder; Brad Marlow, Co- Founder and Derek Fretheim, Chief Operating Officer of Bike Nation on Monday, October 22, 2012. A full report of the meeting will be provided to the Transportation Committee on October 23, 2012.

The meeting has been scheduled in response to a preliminary offer by Bike Nation to implement a "demonstration" bike sharing program within the cities of Beverly Hills, Culver City, Santa Monica and West Hollywood. The program would require a minimum ten year commitment by the cities. According to the offer, no public funding or on-going operational subsidies would be needed.

The offer includes few specific details, thus the ad hoc committee has drafted a detailed list of questions for the meeting. Details to be covered include sponsorship, interoperability, advertising, station locations, implementation and performance guarantees and other matters of interest to the COG Board.
