IV. ITEMS FROM THE SENIOR CENTER AND THE ACTIVITY PROGRAM

There are spaces available to go to the Cleopatra exhibit at the California Science Center on September 28th. The chair Yoga class may switch days. Board members requested information about the programs available at the Freda Mohr Center and Ms. Desser said that she would bring a schedule next month.

- A. Olivia Walker spoke to the Board about classes and excursions offered through the City's Recreation Division and announced that the introduction of the new on-line registration system—Active Net—is going smoothly. She encouraged the Board members to take advantage of the aerobics classes in the pool, which are particularly popular with Seniors.

- C. Daphne Dennis distributed the materials prepared for last year's Board and Commission Congress and asked the Board to review and propose changes or additions for this year's materials.
