The table below indicates the planning permit/application types and the responsible review authority. Certain permit types require a recommendation by an advisory body before the review authority makes its final decision. In these instances, the table below indicates that an advisory body recommendation must come first before a determination by the final review authority. This is indicated by the inclusion of the following symbol "»" between reviewing bodies. For example, a Mills Act Contract requires that the Historic Preservation Commission make a recommendation to the City Council, the final review authority for this type of permit. In the table this is indicated as: HPC » CC.

Decisions by the Community Development Director can be appealed to the Planning Commission. Decisions by the Historic Preservation Commission and the Planning Commission can be appealed to the City Council.
