

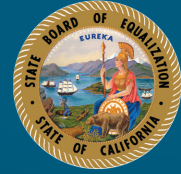

From US-101 South

- Take exit 7 for Santa Monica Bl/CA-2 toward Western Ave.

- Merge onto Beloit Ave.

- Keep left at the fork, destination will be on the left

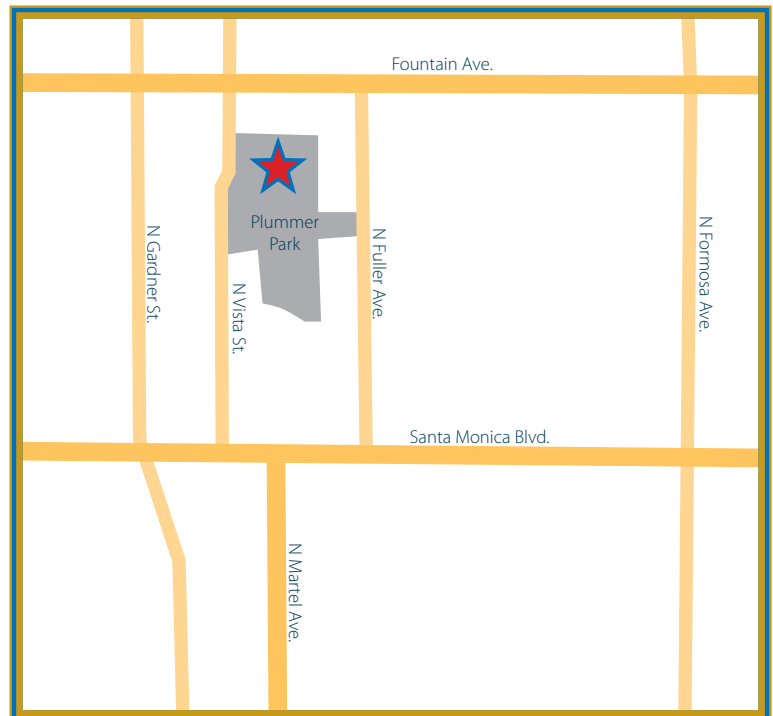
From Interstate 405 North
