Focus on: Sustainable West Hollywood

The General Plan Update offers an opportunity to rethink development and growth patterns in West Hollywood to create a sustainable infrastructure that will help the City remain economically robust, socially equitable, and environmentally healthy.

Providing access to local jobs, housing, and amenities is important to sustainable long-term growth, as is developing our inter-modal transportation system. Nationwide, transportation accounts for over 26% of greenhouse gases, while consuming 68% of oil. "Growing Cooler," a recent study by the Urban Land Institute, concluded that in general, compact communities can reduce driving, measured as vehicle miles traveled (VMT), by 20-40%, while reducing carbon emissions by 7-10%. In addition to reducing oil consumption, pollution, and greenhouse gas emissions, walkable communities can reduce obesity, create vibrant public spaces, and enhance community trust.

West Hollywood benefits from a relatively dense, compact urban form with small lots, a mix of land uses, and a walkable street grid. Commercial corridors, such as Sunset Boulevard, Santa Monica, Beverly and Melrose provide amenities within walking distance of adjacent neighborhoods. During the General Plan Update process, West Hollywood stakeholders will consider where new businesses and housing should be located, choices that can help to reduce the City's environmental impacts. The General Plan Update is an opportunity for the community to discuss and develop ways in which West Hollywood can direct growth to capitalize on its strengths to create a stronger, more sustainable city.

What's Next?

July: A group of highly qualified consultants is preparing technical background reports on a range of issues to be addressed in the General Plan Update. City staff and consultants will present the reports at a City Council meeting in July.

September: A random telephone survey of West Hollywood households, asking questions about a range of critical General Plan subjects will be conducted by a consultant. The survey will help the project team to evaluate key community issues and to accurately represent those concerns in the updated General Plan.
