The Commission received public comment from Chris Hemerlein, Century City resident and West Hollywood business owner. Mr. Hemerlein spoke concerning the opening of Factory West a new gallery in West Hollywood located at 7811 Santa Monica Boulevard and his desire to install a temporary mural on the building's façade.

#### IV. NEW BUSINESS

# A. Laurel House Project

The Commission received an update from staff on the Laurel House Project.

Staff commented that City Council approved the Laurel House Task Force recommendations to refurbish the home and park space. The Task Force will discuss the best uses of the facility at subsequent meetings.

## V. UNFINISHED BUSINESS

# A. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its special meeting held January 31, 2013 and considered ratifying recommendations proposed by the Subcommittee.

- Reviewed a Temporary Art Project Proposal submitted by artist Shana Mabari and received a presentation from the artist on the proposed threedimensional sculpture project, *Illuminated*. Ms. Mabari will report back to the Subcommittee at a subsequent meeting with a revised budget and proposed financial support from the City.
- Reviewed a Temporary Art Project Proposal submitted by LA><ART and received a presentation from Lauri Firstenberg and Amanda Hunt of LA><ART on the proposed three-dimensional sculpture project, Sam Falls Public Sculpture. LA><ART will report back to the Subcommittee with a revised budget and proposed financial support from the City.
- Reviewed a Temporary Art Project Proposal submitted LA><ART and received a presentation from Lauri Firstenberg and artist Anna Sew Hoy of LA><ART on a proposed three-dimensional sculpture project by the artist. LA><ART Will report back to the Subcommittee with a revised budget and proposed financial support from the City.
- Received a presentation from Shawn Mimbs, Lesbian and Gay Advisory Board Member on a proposed utility box art wrap project. It was the consensus of the Subcommittee, should LGAB wish to take the lead on this as a pilot/demonstration project, that the Arts and Cultural Affairs

Commission would likely lend its support for the project. It was also the consensus of the Subcommittee as suggested by staff that LGAB explore the feasibility of a vinyl wrap.

- Received a presentation from Katy Hanson, Aaron Brothers VP of Marketing, Aaron Brothers and artist Michael Giliberti on the public art concept for the West Hollywood Aaron Brothers Store
- Approved for ratification by the Arts and Cultural Affairs Commission Michael Giliberti's proposed art concept for the West Hollywood Aaron Brothers Store with the caveat of removing any logo, type treatments or images within or without the Aaron Brothers' store.
- Received a presentation from Heather Kohos, Chief Brand Officer & Marketing Director at The Roxy, on the proposed installation of a new mural by artist "A Person" on the eastside of the building's exterior in conjunction with The Roxy's online to offline music, art, culture and technology initiative and approved the proposed mural by "A Person" as "art" for ratification by the Arts and Cultural Affairs Commission.
- Received an update from staff on the Temporary Art Project Proposal submitted by artist Richard Kraft to include an updated budget. Approved in concept as a phased project pending budget allocations and talks with the artist and consultant working on the project.
- Discussed as needed Art on the Outside projects under the Subcommittee's oversight.

Following, Commissioner Denenberg moved that the ACAC ratify all recommendations proposed by the Subcommittee including 1) Michael Giliberti's proposed art concept for the West Hollywood Aaron Brothers Store with the caveat of removing any logo, type treatments or images within or without the Aaron Brothers' store; 2) Proposed mural by "A Person" as "art" for installation on the eastside of the building's exterior in conjunction with The Roxy's online to offline music, art, culture and technology initiative; and 3) proposed "100 Walkers West Hollywood" project as a phased project pending budget allocations.

Commissioner Dishman seconded the motion and the motion carried unanimously.

## B. One City / One Pride 2013

The Commission received and filed a list of art and cultural programs scheduled for ONE CITY ONE PRIDE, the City's 6<sup>TH</sup> Annual Festival of LGBT Art and Culture.

# C. West Hollywood Library Arts Programming

The Commission received and filed a list of arts programs scheduled at the West Hollywood Library that included updates on the City's Winter Sounds Concert series.

## VI. EXCLUDED CONSENT

Commissioner Rackley spoke concerning the Performing Arts and Cultural Affairs Subcommittee review of an Arts Participation Grant application submitted by The Art of

Autism to support the West Hollywood ádjacent exhibition, "A Spectrum of Music Art" from March 29 – April 2, 2013 at Mr. Musichead in Hollywood. As a result of its review, the Subcommittee conditionally approved the grant in the amount of \$1,000 pending the submission of additional information pertaining to artist selection, youth engagement and anticipated number of attendees for the opening reception and the entire run of the exhibit. Commissioner Rackley introduced Debra Hosseini, Director of The Art of Autism.

Ms. Hosseini spoke concerning the exhibit that will feature "music art" by persons on the autism spectrum ranging in age from 2 to 65. The autism spectrum consists of over 100 artists worldwide and exhibits are curated by the organization. The artist reception and book signing will be held Saturday, March 23, 2013 from 5 p.m. – 8 p.m. and will feature 77 artists and poets. The event will also feature authors Linda Gund Anderson, "Unintentional Human: Celebrating the Literal Mind and Kelly Green. "Making Friends with Autism" including speaker Dani Bowman and musician Nick Guzman. The organization anticipates that over 100 persons will attend the artists' reception and book signing and up to 1,000 persons will view the exhibit from March 19 – April 2, 2013.

Following, Commissioner Denenberg moved that the ACAC approve an Arts Participation Grant in the amount of \$1,000 to The Art of Autisum to support "A Spectrum of Music Art" from March 19 – April 2, 2013 at Mr. Musichead in Hollywood.

Commissioner Williamson seconded the motion, and the motion carried unanimously.

Commissioner Denenberg spoke regarding *Pacific Standard Time Presents: Modern Architecture in L.A.*, which will be smaller in scope, comprising nine exhibitions and accompanying programs and events in and around Los Angeles slated for April–July 2013.
