A motion was made by Commissioner Maggio and seconded by Commissioner Sanes to approve the minutes from the May 9, 2013 meeting. Motion approved (3-0-0) with Commissioner Topchian and Vice Chair Henry abstaining. A motion was made by Vice Chair Henry and seconded by Commissioner Topchian to approve the minutes of the May 23, 2013 meeting. Motion approved (3-0-0) with Commission Maggio and Commissioner Sanes abstaining.

### **DIRECTOR'S REPORT:**

Director Elizabeth Savage spoke regarding the June 20<sup>th</sup> Planning Commission review of housing programs and an update on progress made since the Housing Element Update that occurred 18 months ago. She encouraged the public to attend or watch on WeHo TV. Ms. Savage also spoke regarding the June 24<sup>th</sup> Joint Study Session of the City Council

and Planning Commission to review the recent Housing Element Update and a review of input that has been received from the community via focus groups, community meeting and various communications received by the department. Ms. Savage also spoke regarding the upcoming reports to the Commission regarding the Annual General Adjustment and Legislative updates.

Acting Manager Anwar Zraikat spoke regarding the updated Hearings and Remedies brochure that is now available to the public.

### **COMMISSION COMMENTS:**

Commissioner Topchian asked for clarification on when a discussion of the Valuations Guidelines may take place. Ms. Savage responded by explaining the in depth nature of the subject and stated that staff is still reviewing the different possible ways in which to move forward on this issue, that it has complexity and staff wants to watch that, if changes are made, those would not cause unintended consequences.

Alison Regan, Legal Counsel, provided a case summary and analysis of the appeal as provided in the staff report.

835 Westmount Dr. (Rent Decrease)

Alison Regan, Legal Counsel, provided a case summary and analysis of the appeal as provided in the staff report.
