



TENANT HARASSMENT COMPLAINT FORM

The West Hollywood Municipal Code prohibits the harassment of tenants by landlords and/or their representatives (Section 17.52.090). A violation may result in a landlord or their representative being charged with a misdemeanor. While you are encouraged to file this form if you believe criminal harassment has occurred, most cases do not meet the legal threshold warranting a referral to the City Prosecutor or prosecution of the alleged violator. This does not mean that a complainant does not have other remedies, but a private attorney of your choice should be consulted regarding your rights on that issue. City personnel cannot give legal advice, but a West Hollywood Legal Resources sheet is available from the Rent Stabilization Division to assist you in finding assistance.

When you file this form, please include copies (not originals) of documentation that you believe supports the allegations set forth in the complaint. Upon receipt, staff will review the complaint and accompanying materials to determine if the allegations and evidence warrant a basis for further review. You will be contacted as to whether an investigation will be commenced or not. If an investigation is opened, City staff will likely contact witnesses, including the alleged violators. The case file will remain in the City's possession and may be confidential and only released upon formal judicial or administrative proceedings.
