#### 9. ITEMS FROM STAFF

# 9A. CAPTAIN ERIC DAVIS, LAPD WILSHIRE

Commissioners received a presentation from Captain Eric Davis, LAPD Wilshire.

Kevin Burton, resident of West Hollywood, spoke regarding the upcoming Community Emergency Response Training class.

Commissioner Williams thanked Captain Davis for his attendance.

#### 9B. NEWS FROM STAFF/MONTHLY CALENDAR OF EVENTS

Staff reminded the Commission that the April meeting will be held on Tuesday, April 1, 2014 at the West Hollywood Sheriff's Station.

Commissioner Williams requested that the Sheriff's Department reserve parking spaces for the Commissioners at that meeting.

#### 10. REPORT FROM THE FIRE DEPARTMENT

Ms. Grycan reviewed the suppression, rescue, and fire prevention activities during the month of February 2014 including inspections, fires, and emergency medical calls. Ms. Grycan spoke regarding the large structure fire at 8430 Santa Monica Boulevard.

Sergeant Klaus stated that it was determined by investigators that the fire at 8430 Santa Monica Boulevard was not arson.

Commissioner Clarkin asked if any firefighters were injured.

Ms. Grycan stated that two firefighters had minor injuries.

Ms. Grycan spoke regarding the upcoming Community Emergency Response Training.

Commissioner Clarkin stated that some Sheriff's volunteers are participating in the upcoming Community Emergency Response Training.

#### 11. REPORT FROM THE SHERIFF'S DEPARTMENT

Sergeant Klaus reviewed the Sheriff's Department statistics for February 2014, including calls for service, arrests, and crimes. Sergeant Klaus stated that Lieutenant Smith and his Entertainment Policing Team have been meeting with clubs regarding unsafe alcohol consumption and over serving patrons.

Sergeant Klaus stated that there were 15 DUI arrests and 5 DUI related crashes in the month of February.

Commissioner Clarkin stated that the next "Walk About with the Captain" will be held on Tuesday, March 18<sup>th</sup> at 5 PM at the Sheriff's Station.

Commissioner Burke stated that the "Walk About with the Captain" will be on the west side and address women's safety issues.

Commissioner Norton spoke regarding parking enforcement officers driving while talking on their cell phones. Commissioner Norton spoke regarding the new crosswalk lights and ways to improve the lighting near cross walks at night.

Commissioner Williams stated that the City is considering other locations for improved lighting. She suggested that Commissioner Burke, as liaison to the Transportation Commission, share Public Safety Commissioners' comments with the Transportation Commissioners.

# 12. REPORT FROM BLOCK BY BLOCK

David Aguilar, Block by Block, gave an update on the activities for February including various calls for service and numerous community contacts.

Commissioner Clarkin spoke regarding the numerous contacts that Security Ambassadors make on both Sunset and Santa Monica Boulevards. Commissioner Clarkin spoke regarding extra bicycle lights from Operation Firefly.

Commissioner Williams thanked Mr. Aguilar for his team's hard work.

# 13A. PUBLIC SAFETY EDUCATION OUTREACH/SOCIAL MEDIA

Commissioner Williams asked staff to speak regarding their calendar and resources.

Staff stated that workshops are possible, but that attendance is usually very low if the workshop is not brought to an existing group. Staff challenged the Commissioners to come up with ideas for locations and better connections for the workshops.

Commissioner Hoffman volunteered to assist staff with messaging and publicity.

Ms. Grycan stated that in the other communities she serves attendance is also a problem and suggests taking it to the neighborhood and utilizing a recent event to start the conversation; for example fire safety in a building that has recently experienced a structure fire.

Commissioner Williams asked that next month's agenda include an item on the upcoming Human Trafficking seminar hosted by NCJW. Commissioner Williams spoke regarding a gun violence seminar on March 12, 2014.

Commissioner Norton suggested working in conjunction with targeted Boards and Commissions on shared issues.

Commissioner Hoffman asked staff to arrange an introduction to the Rent Stabilization and Housing Manager to discuss their flyer advertising upcoming seminars.

Commissioner Clarkin suggested that the group look at the newer, successful events such as Buff 'n Cut.

Commissioner Williams suggested having specialty speakers come to the Public Safety Commission.
