#### 4. ADJOURNMENT REQUESTS

Commissioner Sol requested that the meeting be adjourned in the memory of West Hollywood resident Michael Bronoski and the 17 law enforcement officers and firefighters who have passed away since the last meeting.

#### 5. APPROVAL OF THE AGENDA

**ACTION:** Motion by Commissioner Sol to approve the April 1, 2014 agenda, seconded by Commissioner Norton, and approved.

#### **POSTING OF THE AGENDA**

The agenda for the April 1, 2014 Public Safety Commission meeting was posted at City Hall, Plummer Park, and the West Hollywood Sheriff's Station, and the West Hollywood Library.

#### 6. APPROVAL OF MINUTES

**ACTION:** Motion by Commissioner Norton to approve the March 10, 2014 minutes, seconded by Commissioner Burke, and approved, with Commissioner Sol abstaining.

#### 7. PUBLIC COMMENTS

Stephanie Harker spoke about safety concerns with motorized scooters and motorized toy cars being driven by children at Plummer Park.

#### 8. COMMISSIONER COMMENTS AND LIAISON REPORTS

Commissioner Clarkin spoke regarding how much Captain Davis from LAPD appreciated the Commission reading the fallen officers list.

Commissioner Sol spoke about the event Connect Our Stories hosted by the Lesbian and Gay Advisory Board, the Russian Advisory Board and the Transgender Advisory Board. Commissioner Sol also spoke about connecting with the Boards that she represents as a liaison.

Commissioner Norton thanked the audience for raising the issue of motorized scooters and vehicles in Plummer Park. Commissioner Norton spoke about attending the Senior Advisory Board meeting. The Senior Advisory Board and the Disabilities Advisory Board will be having a joint televised meeting next month dealing with senior housing.

# 9A. LIAISON SELECTION TO THE WEHO DESIGN DISTRICT STREETSCAPE MASTER PLAN

Commissioners received a presentation from Georgia Sheridan from the Community Development Department. Ms. Sheridan asked that a member of the Public Safety Commission sit on the West Hollywood Design District Streetscape Master Plan Community Design Committee.

**ACTION:** Motion by Commissioner Clarkin to appoint Commissioner Burke as primary and Commissioner Sol as alternate to the West Hollywood Design District Streetscape Master Plan Community Design Committee, seconded by Commissioner Norton, and approved.

## 10. REPORT FROM THE FIRE DEPARTMENT

#### 11. REPORT FROM THE SHERIFF'S DEPARTMENT

Sergeant Klaus reviewed the Sheriff's Department statistics for March 2014, including calls for service, arrests, and crimes. Crime is down over 45% for the year. Lt. Smith stated that working with Block by Block is another reason crime is down in the City.

Lt. Smith announced upcoming dates that would be of interest to the Commission: April 11, 2014, DUI Checkpoint; April 16, 2014, Trans 101 for Deputies; April 23, 2014, Captain's Walkabout.

Sergeant Klaus stated that there were 11 DUI arrests and 3 DUI related crashes in the month of March. Sergeant Klaus also reported on the number of traffic collisions regarding pedestrians and bicyclists.

Commissioner Sol spoke about the new developments on the east side near Target and the Gateway, and asked if they have affected Block by Block. David Aguilar from Block by Block stated he has seen no increase in activity.

Lt. Smith asked David Aguilar to invite the security companies that oversee building construction to attend the next meeting.

## 12. REPORT FROM BLOCK BY BLOCK

David Aguilar, Block by Block, gave an update on the activities for March including various calls for service and numerous community contacts.

Commissioner Clarkin spoke regarding the numerous contacts that Security Ambassadors make on both Sunset and Santa Monica Boulevards. Commissioner Clarkin requested that Sunset Block by Block ambassadors attend the next meeting.

Commissioner Norton asked Block by Block for a one page monthly report with stats for the next meeting.
