IV. LEGISLATION & ADVOCACY DISCUSSION

A. Updates

- Equal Pay Day
 Staff updated the board that their Equal Pay Day Event will take place at
 the April 7, 2014 West Hollywood City Council meeting. Boardmember
 Stephanie Cubba will make a short presentation regarding Equal Pay Day
 and then people will move into the lobby for a reception.
- Local Implementation of Senate Bill 1193
 Staff informed the Board that there will be a training sessions about the local implementation of Senate Bill 1193 by the National Council of Jewish Women Los Angeles at the 8th Annual Women's Leaderhship Conference and encouraged them to attend if they were interested in learning more.

Women in Leadership Awards -

Boardmembers discussed the recent Women in Leadership Awards ceremony at Phyllis Morris. Boardmembers commented on how much they enjoyed the event and how it was well-received through all the attendees they spoke with. Boardmembers commented on how inspiring it was to hear from all of the women who were being honored.

International Women's Day -

Boardmember Salguero commented that she attended the event and that it was a great celebration of different cultures. Boardmember Salguero commented that people left early on because the event didn't have any food and only water.

A. West Hollywood Report on the Status of Women

Corri Planck, Social Services Program Administrator gave a presentation to the Board regarding the release of the City's *Status of Women in West Hollywood Report* and discussed the directive to the Board from the City Council to generate a report on the status of women in West Hollywood based on the Community Study that was recently completed in April, 2013.

Boardmembers asked questions relating to the data presented in the report and requested additional statistical information from Staff.

Staff informed the Board that the City's Social Services agencies are available to come and brief the board about the services they provide to help them understand the scope of what the City provides for residents.

Staff recommended that the Board further examine and assess the report and come back to it at their future meetings and utilize it as it relates to the Board's main priorities such as pay equality and public safety.

Boardmember Noemi Torres commented that she had met with Ashley Millhouse from the American Cancer Society – Relay for Life and how they were working together in planning a future event to raise awareness for Relay for Life.
