MINUTES INTERIM BUSINESS LICENSE COMMISSION

November 18, 1986

I. CALL TO ORDER

Commission asked questions of Attorney Mayok, Deputy Lincoln of the Sheriff's Department and Attorney Bagneris. Staff members Self and McKinney informed the Commissioners that they had made an on-site inspection of facility on the morning of November 19 and reported that the entire booth area was not visible from the video cameras in the arcade. Deputy Lincoln presented photographs of the interior of the arcade and certified documents of all cases handled by the Beverly Hills Municipal Court.

Sheriff's Conditions:

- 1. There shall be a licensed manager on the premises at all times.
- The employment of managers shall not be permitted until such time as they have licenses approved by the investigating agencies and have in their possession a valid license, not a receipt.
- 3. Managers shall have valid identification with them at all times.
- 4. There shall be at least one uniformed security guard patrolling the interior of the location at all times to discourage any lewd acts on the premises.
- 5. Licensee shall not permit any lewd activity, as defined in Penal Code Section 647(A) and 647(B), in the location.
- 6. Licensee shall post a sign in each booth warning customers that they may not engage in lewd activities on the premises.
- 7. A viewer within a booth shall be fully clothed at all times.
- 8. The booths shall be occupied by only one (1) person at a time.
- 9. All booths, including the interior of each booth, shall be visible with the human eye immediately upon entry into the premises. Such visibility does not include the use of closed circuit cameras. If construction or remodeling is required licensee shall not operate said business until compliance is met.

Staff's Conditions:

 That the applicant comply with the conditions stated in the Sheriff's Department investigative report for said business licenses.

 That the applicant comply with all provisions of the City's Sign Ordinance under Article IX, Chapter 9440 of the West Hollywood Municipal Code.
