Deputy Lincoln stated that he had met with Captain Squeirs of the West Hollywood Sheriff's Station on the issue of requiring a licensed security guard at each nightclub establishment. The Sheriff's Department suggested handling the issued of required security guards on a case-by-case basis for each nightclub which may require such a guard.

The Commission directed staff to develop proposed definitions of a nightclub and gave Staff suggestions on factors that should be considered in developing a nightclub definition.

Commissioner Hirsch stated that he has met with members of the City Council regarding business license code enforcement staffing needs.
