Staff reported the following:

1. The City Council acted to establish a permanent, five-member business license commission and final appointments would be made at the April 20 Council meeting.
2. The Council will conduct hearings on Appeals to the business license commission on March 30.
3. Staff has begun preparation of revised procedures for Appeal and Accusation hearings, and Noticing requirements for hearings. Staff recommended the Commission hold a study session to discuss these procedures.
4. Staff has received a letter of resignation from Commissioner Sweeney, effective March 3, 1987.
5. The procedures used in the Accusation hearing of March 3, 1987 have been reviewed by the City Attorney's office and found to be in order, and the Commission may continue the hearing on April 7, 1987. A revised accusation has been received and copies distributed to the commission.
6. Staff asked Commission if they would like a monthly roster of new and renewal business license applications.




