# MINUTES INTERIM BUSINESS LICENSE COMMISSION

# January 6, 1987

### I. CALL TO ORDER

#### IV. STAFF REPORT

Staff reviewed the impact of the new legislation which took effect January 1, 1987 which amends the Brown Act and prohibits local legislative bodies from taking action on items not appearing on the written agenda.

Staff mentioned that the 2nd Council meeting in January will fall on the same day as the next regularly scheduled Business License Commission meeting, on January 20, because of the Martin Luther King, Jr. holiday. Staff recommends that the Commission adjourn to the regularly scheduled meeting of January 20, but the meeting of the 20th would be adjourned for lack of quorum and adjourned to February 3.

Staff reports on nightclub legislation and business licensing will be presented to Council on January 20. A meeting with community representatives will be held on Thursday, January 8, in the West Wing Conference Room.

Staff reported that appeals have been filed by applicants for three of the hearings heard by the Commission. Appeals will be heard by the City Council.

- c. Applicant must only allow dance and entertainment to take place as an accessory use to the restaurant and ballroom facilities of the hotel.
- d. Applicant may not use any ballrooms or other facilities in the hotel as a nightclub, disco, theater, dance hall, cabaret or any other similar type of dance or entertainment facility regularly or periodically open to the public, or as a private club regularly or periodically open to members of the club.
- e. In order to ensure that the ballroom facilities remain an accessory use to the hotel and do not take on the character of a nightclub, the applicant shall adhere to the following:
  - (1) Evening use of the ballrooms is to be exclusively for private events. These events must be reserved in advance and be non-recurring (limited to no more than two events, per year, for any one organization or individual.)
  - (2) Organizations or individuals using the ballroom facilities must be established organizations sponsoring organizationally related events or individuals hosting wedding receptions, family reunions, anniversary celebrations or similar events.
  - (3) Entrance to these events shall be by advance invitation only and in no event shall the ballroom facilities be used for activities which allow, permit, encourage, or are open to members of the general public not specifically invited by name to the event, or which invite
