Action: To approve an Entertainment-General license for Ciro Orsini dba Pizza Pomodoro restaurant with the following conditions:

- 1. Final license approval is subject to the approval of Minor Conditional Use Permit #87-15 by the Director of Community Development and a subsequent recommendation for approval of the license application by the Planning Division.
- 2. The applicant must abide by all of the conditions stipulated in Minor Conditional Use Permit #87-15.
- 3. Entertainment shall be as an accessory use only to the restaurant.
- 4. The applicant will abide by the provisions of Section 7.36 of the West Hollywood Business License Ordinance (Entertainment license regulations).
- 5. The applicant will abide by the provisions of Section 4307 of the West Hollywood Municipal Code (Noise Ordinance) and agrees to provide adequate soundproofing, as needed.
- or company providing valet parking for the applicant in the conduct of the applicant's business, will be properly licensed as required under Section 7.86 of the West Hollywood Business License Ordinance and that the applicant must provide 1-1/2 hours of free valet parking for each patron.
- 7. The applicant will ensure that valet parking pick-up take place on Beverly Blvd. only, in front of the business establishment.
- 8. Entertainment shall consist of 1 singer and 1 instrument, for quiet music only.

- 9. After 9:00 p.m., on the days in which the establishment is open for business, patrons may only enter through the Beverly Blvd. entrance, which shall remain unlocked but closed during the hours of operation. All other doors must remain unlocked but closed and are to be used for emergency exiting of patrons only.
- 10. The hours of operation for entertainment shall be Sunday through Thursday, from 10:00 a.m. to 10:30 p.m., only, and on Friday and Saturday, from 10:00 a.m. to 12:00 a.m., only, on the days in which the establishment is open for business. It is recommended to the Director of Community Development that Condition #16 in the Conditions for Minor Conditional Use Permit #87-15 reflect that the "weekend" refer to Friday and Saturday.
