- 4. Applicants agree to comply with all provisions of the City's Noise Ordinance (Art. IV, Ch. 3, W.H.M.C.) and provide adequate soundproofing, as needed.
- 5. The hours of operation for the entertainment and dance establishment shall be: 1) Sunday through Thursday from 8:00 p.m. to midnight; 2) Friday and Saturday from 8:00 p.m. to 2:00 a.m., on the days on which the establishment is open for business.
- 6. Staff shall present a six-month review from the date of this hearing with a report presented to the Commission.

Action: To approve an Outdoor Festival business license for Christopher Street West Association, Inc. to conduct their annual Gay Pride Festival at West Hollywood Park on June 25 and 26, 1988, with the following conditions:

- 1. Recommendations for approval must be given by the City's Building and Safety division and the County Fire, Health and Sheriff's Department, before release of the Outdoor Festival license.
- The applicant must secure a Temporary Use Permit from the City's Planning Division.
- 3. The applicant must abide by the terms of the contract between the applicant and the City of West Hollywood for the use of the park facilities.
- 4. The hours of operation for the event shall be from 10:00 a.m. to midnight, on Saturday, June 25th, and from 10:00 a.m. to 11:00 p.m., on Sunday, June 26th.
- 5. The applicant shall allow no more than 20,000 persons into the Festival area on Saturday, June 25th and no more than 30,000 persons into the Festival on Sunday, June 26th.
- 6. The applicant agrees to comply with the provisions of the City's Noise Ordinance (Article IV, Ch. 3, W.H.M.C.)
- 7. The applicant agrees to provide off-site parking spaces for festival staff, vendors and guests equal to one-tenth of the number of festival guests allowed by this license.
- 8. The applicant shall submit a letter from the Pacific Design Center stating that the Pacific Design Center has agreed to allow Christopher Street West Association, Inc. to use the parking structure owned and operated by the Pacific Design Center for parking for festival vendors and guests. The letter shall also state the hours the parking structure shall be open, the cost for parking of each vehicle and the number of spaces available.

- 9. The applicant shall only allow to be consumed on the premises those alcoholic beverages specifically sold by the applicant on the festival grounds. No bottles or cans of alcoholic beverages are allowed on the festival grounds and alcoholic beverages served are restricted to beer and wine only. Alcoholic beverages must be paid for with tickets purchased at a separate location on the festival grounds.
- 10. The applicant shall submit a site plan showing the location of the proposed festival, and the location of the staging area, loudspeakers, toilet facilities, interior access, medical facilities and drinking facilities.
- 11. That the Commission waive the current Outdoor Festival license requirements for parking, drinking fountain facilities, the prohibition of the sale of alcoholic beverages and the mailing of notices to property owners within a 500' radius of the event, as indicated in this staff report.
