-- Meeting recessed for 10 minutes --

Action: To approve the renewal of Entertainment w/Dance and Annual Dance business licenses with the following conditions:

- 1) That the licensee allow patrons to only enter through the Santa Monica Boulevard exit and that the Santa Monica Boulevard exit be the main entrance and exit to the licensee's establishment.
- That the licensee shall prohibit patrons from entering or exiting the north, rear exit of the licensee's establishment except as an emergency exit only.
- 3) That the licensee shall post signs at the business establishment directing patrons to Santa Monica Boulevard for valet pick-up; and that there be sufficient lighting for that purpose.
- 4) That the licensee hire a licensed security guard to monitor the rear parking lot of the licensee's business establishment and to control noise generated by patrons in the parking area. Said security guard shall patrol the rear parking lot from 5:00 p.m. to 2:30 a.m. on the days in which the licensee's establishment is open for business.

(Motion: Hirsch, Second: Ellis)

Motion amended by Ellis to add:

1) That the license be approved for a period of sixty (60) days and that staff report back to the Commission on the status of the license at the end of sixty (60) days.

2) That the conditions set forth by the Commission shall be effective two (2) weeks from the decision of the Commission.

Amendment accepted by Hirsch

Motion amended by Smith to add:

- 1) That the licensee must receive recommendations of approval of the license renewal from all responsible agencies.
- The licensee must continue to abide by all previous conditions set forth on the licensee's Entertainment and Dance licenses with the exception of Condition #1 and #6 which shall be modified to read:
 - "1. That the license show the occupancy load of 202 as established by the Building and Safety Division and the Fire Department.
 - "6. That the requirement of a dressing room be waived as long as entertainment shall consist of instrumental music and singing or "stand-up" comedy routines only."
- The licensee shall prohibit patrons from reentering the business establishment without first paying the required cover charge, pursuant to Section 7.30.490 of the City's Business License Ordinance.
- 4) The licensee shall post a sign at the north, rear exit of the licensee's establishment informing patrons that they must exit through the Santa Monica Boulevard exit.
- 5) That there be a 6-month trial period instead of 6-week.
