- 9) The applicant shall submit a site plan showing the location of the proposed festival, and the location of the staging area, loudspeakers, toilet facilities, interior access, medical facilities and drinking facilities;
- 10) The applicant shall notify all tenants and property owners within a 500' radius of the proposed event;
- 11) That the Commission waive the current Outdoor Festival license requirements for parking, drinking fountain facilities, and the prohibition of the sale of alcoholic beverages; and
- 12) The applicant must post notice at each booth where alcoholic beverages are sold stating the following: "Alcoholic beverages are prohibited to be consumed by persons under 21 years of age."
