# APPLICANT TESTIMONY:

Richard Dear, Legal Representative, San Marino Jerry Gould, Los Angeles

Action: To approve a Card and Game Club business license application for Philip Marks and Jerry Gould dba West Hollywood Club with the following conditions:

- The games indicated (Bridge, Gin, Backgammon and Pinochle) will be played only as indicated and enumerated in the original application. Any variation of gaming concept must be submitted in writing and approved prior to inception. Attached are copies of the house rules for Gin, Backgammon and Pinochle. The bridge game will be played under "The International Code; Laws of Contract Bridge." The code is published by the American Contract Bridge League;
- 2) Notwithstanding adherence to the provisions and/or revisions, Section 330 of the California Penal Code will set precedence in any and all present or future gaming concepts;
- The applicant shall maintain strict compliance with Sections 4125 through 4130 of the West Hollywood Municipal Code;

- The licensee or his representative shall not charge and collect a percentage of the player's winnings. The licensee may charge a fee for a seat rental at a table and that fee must be based upon the time that the player utilizes the seat/chair. The utilization is determined by the length of time that each player is seated at a table and plays a specified game;
- The former owner(s) and/or management shall not have any involvement in the new business. This includes administrative, supervisory, consulting, managing or any other function that would involve them in the operation;
- 6) There shall be no games played at the location that are not commonly recognized as one of the games described in Condition #1;
- 7) All provisions of Chapter 7.22 of the West Hollywood Municipal code regarding the operation of Card and Game clubs shall be strictly adhered to;
- 8) The approved license shall be subject to a one-year review by staff with a report to the Commission on the operation of the licensed establishment.

# APPLICANT TESTIMONY:

Gary Jonker, Los Angeles

Action: To approve an Outdoor Festival business license application for the Christopher Street West/Los Angeles, Inc. to conduct an annual Gay Pride Festival in West Hollywood Park and on San Vicente Blvd. between Santa Monica Blvd. and Melrose Ave. on June 24 and 25, 1989 with the following conditions:

1) Recommendation for approval must be given by the City's Building and Safety Division and the County Fire, Health and Sheriff's Departments, before release of the Outdoor Festival license and the conduct of the Festival;

- 2) The applicant must secure a Temporary Use Permit from the City's Planning Division;
- The hours of operation for the event shall be from 10:00 a.m. to midnight on Saturday, June 24th, and from 10:00 a.m. to 11:00 p.m. on Sunday, June 25th, 1989;
- 4) The applicant must not violate the provisions of the City's Noise Ordinance as set forth in Section 4300 of the West Hollywood Municipal Code;
- 5) The applicant shall allow no more than 20,000 persons into the Festival area on Saturday, June 24th and no more than 30,000 persons into the Festival area on Sunday, June 25, 1989;
- 6) The applicant agrees to provide off-site parking spaces for festival staff, vendors and guests equal to one-tenth of the number of festival guests allowed by the license;
- 7) The applicant shall submit a letter from the Pacific Design Center stating that the Pacific Design Center has agreed to allow Christopher Street West, Inc. to use the parking structure owned and operated by the Pacific Design Center for parking for festival vendors and guests. The letter shall also state the hours the parking structure shall be open, the cost for parking of each vehicle and the number of spaces available;
- 8) The applicant shall request that the West Hollywood City Council waive permit parking in Permit Parking Districts #1 and #2;
- 9) The applicant shall only allow to be consumed on the premises those alcoholic beverages specifically sold by the applicant on the festival grounds. No bottles or cans of alcoholic beverages are allowed on the festival grounds and alcoholic beverages served are restricted to beer and wine only. Alcoholic beverages must be paid for with tickets purchased at a separate location on the festival grounds;

- 10) The applicant shall submit a site plan showing the location of the proposed festival, and the location of the staging area, loudspeakers, toilet facilities, interior access, medical facilities and drinking facilities;
- 11) That the Commission waive the current Outdoor Festival license requirements for parking, drinking fountain facilities, the prohibition of the sale of alcoholic beverages and the mailing of notices to property owners within a 500' radius of the event, as indicated in this staff report.
