I. CALL TO ORDER: Chair Sonnenburg called the meeting to order at 6:30 P.M.

B. PLEDGE OF ALLEGIANCE: The pledge of allegiance was led by Commissioner Stalford.

C. APPROVAL OF AGENDA:

Action: To hear item IX (Old Business) immediately following item III (Items From Citizens) on the agenda in order to allow those in the audience to hear this item of interest (item IX B), and to approve the agenda as amended.

II. CONSENT CALENDAR

A. Approval of Minutes for 23 October 2001.

B. Oath of Office for New Commission Members

Code Compliance Manager Wade Davenport announced, to the Commission, that the swearing in of recently appointed commissioners would take place at the December 11th meeting and continued that the empty commission seats would be filled by Terry Morgan, a direct council appointment made by Councilmember Martin, Sibyl Zaden and Alexander Ponder the two at large appointments made by the Council.

III. ITEMS FROM CITIZENS

A. Hillary Selvin, Executive Director, West Hollywood Chamber of Commerce, reminded the Commission that citations issued to businesses are not always outright violations but are sometimes honest mistakes made by the business and asked the Commission to keep citations in perspective when reviewing a businesses activities. Ms. Selvin continued that citations should be used to educate businesses and as a tool to gain compliance and should not be used punitively and suggested that Code Compliance and businesses should work together in attaining this goal. She also offered assistance from the Chamber in working with businesses and the City to achieve compliance or compromise when needed.

IV. OLD BUSINESS

A. Six (6) month review of Resolution BL2001-02, conditions of approval for The Trocadero Restaurant located at 8280 Sunset Boulevard.

Officer Jeffrey Aubel presented the staff report.

- Stated that to date no additional noise violations have been reported since the August 7th, three month review of The Trocadero.
- The seating plan approved under MCUP 95-01 is still in violation and has been returned twice because it was incomplete.

Officer Aubel concluded that Staff is recommending that a pubic hearing be agendized for the December 11th Business License Commission meeting to modify, suspend or revoke business licenses for The Trocadero, or if the application is complete at that time, conditions placed on the restaurant could be removed.

VI. COMMISSION CHAIR'S REPORT

Chair Sonnenburg reported that she has attended several meetings of the Sunset Boulevard task force which is currently discussing the definitional differences between a restaurant and a nightclub. Chair Sonnenburg stated that the discussions are ongoing and that she would keep the Commission updated as information becomes available.

Thompson asked Staff if copies of the business license ordinance are given to persons receiving new regulated business licenses?

Staff responded that the entire ordinance is not given but that staff regularly sits down with new business operators and gives them the necessary information relating to the City's requirements of each business type.

Sonnenburg inquired if giving copies of applicable sections of the code to all new business licensees would be too onerous?

Staff suggested that meeting with new licensees has been more effective with the present code but that the newly proposed code will better lend itself to giving information about specific business types to new applicants and licensees.
