# III. COMMISSION CONSIDERATION

A. Nightclub Standards Report.

A staff report was presented by Anne Browning.

#### PUBLIC COMMENTS

Thomas Crail, W. Hollywood - spoke on behalf of the Chamber of Commerce and local business owners/operators. Made suggestions that he felt would be helpful in drafting permanent nightclub standards for the City.

#### PUBLIC COMMENTS

Rochelle Sommers-Smith, W. Hollywood - asked for continued public noticing to neighborhoods directly affected by nightclub problems. Spoke regarding continued problems occurring at nightclubs on Sunset Strip. Mentioned the possibility of of installing a separate phone line at the W. Hollywood Sheriff's station.

#### COMMISSIONER COMMENTS

Commissioners Elliott and Ellis asked questions of Mr. Crail.

There was continued discussion amongst the BL Commissioners regarding establishing standards for nightclubs.

Commissioner Sonnenburg submitted a draft outlining a definition of "nightclubs".

Staff offered to research draft with City Attorney's office and come back to BLC with an amended version of Commissioner Sonnenburg's initial draft.

The BLC continued discussions (by line item) of Thomas Crail's proposed list of nightclub standards.

#### ADDITIONAL PUBLIC COMMENTS

Sam Morocco, W. Hollywood - stated that off-duty police officers cannot make arrests of citizens and are not cost effective.

# ADDITIONAL COMMISSIONER COMMENTS

The BLC examined the drafted nightclub matrix. Suggestions were offered to supplement existing language.

Discussion continued regarding what issues were within the purview of the BLC (parking - land use - planning/zoning issues v. BLC issues).

The BLC ended discussions on the establishment of setting up of nightclub standards.

Staff was directed to come back to BLC with additional information.
