VI. COMMISSION CHAIR'S REPORT:

- 1) Commissioner Ellis raised the question about the alleged S & M activities at the Christopher Street West festivities last June. Corey Roskin reported that Christopher Street West officials were aware of the situation and that it had been discussed at a meeting between CSW, the Sheriff's Department, and other officials.
- 2) Commissioner Ellis asked about items on upcoming Business License Commission agendas. Bill Meeker noted that at this point there are no public

- hearings or case items scheduled for the next meeting on September 18, 1990.
- 3) Commissioner Ellis noted that the reports from the various agencies should be included in the Commissioners' packets.

VII. ITEMS FROM COMMISSIONERS:

- 1) Commissioner Elliott asked about the type of ABC license held by Barney's Beanery. Bill Meeker reported that staff was scheduled to meet with a representative of the Alcoholic Beverage Control Board on August 22, 1990, and would pose that question along with several others, including finding out the definition of a private party.
- 2) Commissioner Elliott asked staff whether the Commission was scheduled to review Palette's license. He feels that they were able to circumvent the Business License Commission. Bill Meeker informed the Commission that there was no review scheduled for Palette by the Business License Commission.
- 3) Commissioner Elliott asked staff for an annual calendar indicating which clubs would be coming up for review by the Business License Commission.

 Corey Roskin reported that "Circus of Books" was the only license scheduled for review.
- Commissioner Maggio asked staff whether they were certain that Roxbury would be enlarging their stairways and hallways, and whether this would be accomplished by the next 6-month review. Bill Meeker informed the Commission that there would be no further 6-month review for the Roxbury and that the enlargement of their stairways and hallways was not required since it is not a condition of their license.

VIII ITEMS FROM STAFF:

- Bill Meeker advised the Commission that there is a budgeted amount of \$400 per Commissioner available for conferences and seminars during the 1990/91 fiscal year. Staff will keep the Commission advised of any conferences or seminars of interest, and likewise, the Commissioners should advise staff if they become aware of anything.
- 2) Bill Meeker noted that the Planning Commission had recently held a retreat with staff, and that staff was strongly recommending that the Business License Commission also consider holding a retreat with staff. Bill suggested that a retreat be held on an

alternate Tuesday from the regular Commission meeting date and that November might be a good month.

3) Upon Bill Meeker's suggestion, the Commission discussed which day would be best for the regularly scheduled Commission meetings. It was decided that the meetings would be held on the first Tuesday of each month, except for September.

IX. ITEMS FROM CITIZENS:

- Rachelle Sommers Smith, West Hollywood, thanked the Commission for the plaque that had been presented to her. She urged the Commission to continue to lobby the City Council to include an annual review of the nightclubs in the Business License Ordinance. Also, she advised the Commission that in May 1989, the Commission approved the license for the Cavendish Card Club with the condition that the approved license was subject to a one-year review by staff with a report to the Commission on the operation of the licensed establishment. Since there has never been a report, she asked the Commission to follow up with staff. Bill Meeker indicated that staff would follow up.
- Gerda Spiegler, West Hollywood, was looking for 2) some clarification regarding the review process conducted by the Business License Commission. noted that the Commission was being advised by staff not to ask certain questions that had been addressed at the time the license was granted; whereas, she feels that the Commission has a right to ask anything they like in the review process. Bill Meeker responded that the purpose of the six-month review process is not to rehash the issues that were initially researched at the time of the original business licensing process; it is merely a monitoring mechanism to determine if any complaints or serious issues have arisen in that initial review period which may warrant the calling of a public hearing to bring back the license for review and the attachment of additional conditions. He explained that that is the reason for steering the Commission away from rehashing issues that were fully researched previously, such as occupancy load and parking requirements.

IX. ADJOURNMENT:

Commissioner Ellis adjourned to the next regularly scheduled meeting of the Commission on September 18, 1990, to be held in the Werle Building at 7:00 p.m.
