APPLICANT TESTIMONY:

Barbara Burns, City of West Hollywood Judith Wilson, Studio City

Action: To approve the application for an Outdoor Festival business license for the Institute of Business Designers to conduct the First Annual Beaux Arts Festival in West Hollywood on September 10, 1989, with the following conditions:

- The hours of operation for the event shall be from noon to 10 p.m.;
- The applicant must not violate the provisions of the City's Noise Ordinance as set forth in Section 4300 of the West Hollywood Municipal Code;
- The applicant shall allow no more than a total of 8,000 persons into the festival area during the Festival;
- 4) The applicant agrees to provide off-site parking spaces for festival staff, vendors and guests equal to one-fifth of the number of festival guests allowed by the license;

- The applicant shall only allow to be consumed on the premises those alcoholic beverages specifically sold by the applicant on the festival grounds. No bottles or cans of alcoholic beverages are allowed on the festival grounds and alcoholic beverages served are restricted to beer and wine only. Alcoholic beverages must be paid for with tickets purchased at a separate location on the festival grounds;
- The Commission waive the current Outdoor Festival license requirements for drinking fountain facilities, the prohibition of the sale of alcoholic beverages, as indicated in the staff report;
- 7) The applicant shall provide a person to monitor the library parking lot. That those spaces be used for and by library patrons only; and
- 8) That the applicant post signs stating that no one under the age of 21 shall purchase or consume alcoholic beverages.
