#### IV. NEW BUSINESS

## A. Introduction City of West Hollywood Public Information Division

The Commission received an introduction and presentation from Public Information Officer Joshua Schare on the Public Information Division's three strategic initiatives.

The Public Information Division will focus on:

- a. Transforming the City's media database capacity and media monitoring to include expanded access to PRweb, analytics, metrics, and custom reports with new, cutting edge, web-based data technologies,
- b. Development and implementation of a proactive media relations program with emphasis on promotion and media pitching of City services, special events, arts and culture and other programs and initiatives.
- c. Integration of a strategic plan for the City's Communication and Civic Engagement programs in addition to organization branding exercises to develop tools for City staff and City officials to use when describing City programs and initiatives.

#### V. UNFINISHED BUSINESS

## A. Art Process Team - West Hollywood Park Master Plan Phase II

The Commission received a report from members of the Art Process Team – West Hollywood Park Master Plan Phase II Implementation Project on its meeting held May 15, 2014.

Commissioner Denenberg reported the Art Process Team received a presentation from public art consultant Rebecca Ansert, Green Public Art, who presented potential artists for West Hollywood Park Master Plan Phase II Implementation Project. As a result, the APT recommended four (4) artists or artist teams from the pool of artists to submit site-specific proposals/art concept plans for the site.

Artists selected for this phase of the project are:

**Luke Jerram** fuses his artistic sculptural practice with his scientific and perceptual studies. He is known worldwide for his large scale public engagement artworks.

**Adam Kuby** works are collaborations with the built and natural world that foster a sense of connectedness in our increasingly fractured environment. Each site offers the chance to explore how human and non-human ecologies can better coexist through parallel layers of meaning and purpose, and contemporary place-making. He studied and worked in the fields of landscape architecture, sculpture, urban forestry, zoo habitat design and landscape restoration.

## Patricia Leighton, Del Geist and Taewook Cha (Artist Team)

Patricia Leighton has been making art in the public realm for over 25 years, creating large-scale permanent commissions worldwide, which relate to the history of a given site and the relevant environmental and ecological conditions.

Del Geist has integrated art into the public realm for more than 30 years. As an artist, using the natural sciences as a palette, he has developed major site-specific artworks throughout the US and Europe. His environmental artworks elicit unique qualities inherent to a place, fostering a viewer's direct sensory experience.

Taewook Cha is a registered landscape architect and founding principal of Supermass Studio where he oversees all design process in the office. He has been playing a key role in coordinating a team of multidisciplinary consultants as well as leading and managing design and implementation of projects.

**Phillip K. Smith, III** continues to push boundaries and confront the ideas of modernist design. Drawing inspiration from the cold rigidity of the Bauhaus movement, the reductive geometries of minimalism, and the optic sensation of California's Light and Space movement, Smith attempts to resolve the complex challenge of finding a natural state of life and spirit within these ideological aesthetic constrictions, the results are deceptively simple and compelling objects that seem to breathe and move as you observe and interact with them.

## B. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held May 22, 2014, and considered ratifying recommendations proposed by the Subcommittee.

At the meeting the Subcommittee

a. Reviewed and discussed the three-dimensional sculpture project "The Fractured Heart" by artist Duane Paul for installation in West Hollywood Park from September 2014 through February 2014.

It was the consensus of the Subcommittee not to recommend this project to the full Commission.

b. Reviewed and discussed a Temporary Visual Art Project Proposal submitted by LA><Art.

It was the consensus of the Subcommittee that LA><Art submit a revised proposal detailing its public art initiative to include artist bios, images and other supporting documentation that would aid the Subcommittee in making its decision.

c. Reviewed a Temporary Art Project Proposal submitted by artist Hacer as part of its discussion on Art on the Outside exhibition and programming opportunities for 2015.

The Subcommittee approved in concept a three-dimensional sculpture project consisting of up to four (4) works by Hacer for installation on the Santa Monica Boulevard/Doheny median for a period of up to 18 months beginning December 2014 and noting direction for staff to explore with the artist the feasibility of extending the presence of the sculpture project along the Santa Monica Boulevard/Doheny median.

- d. Received a presentation by art consultant Rebecca Ansert on a proposed call for artist process that was conducted in Newport Beach that might serve as a template for a similar process in West Hollywood. It was the consensus of the Subcommittee that the Newport Beach call for artist was not a best fit for West Hollywood. The Subcommittee reiterated its interest in an invitational call for artists in collaboration with other art institutions.
- e. Received an update from staff and art consultant Rebecca Ansert on current AOTO Projects and discuss as needed AOTO projects under the Subcommittee's oversight.

ACTION: Approval in concept of a three-dimensional sculpture project consisting of up to four (4) works by Hacer for installation on the Santa Monica Boulevard/Doheny median for a period of up to 18 months beginning December 2014 and noting direction for staff to explore with the artist the feasibility of extending the presence of the sculpture project along the Santa Monica Boulevard/Doheny median. Motioned by Commissioner Denenberg seconded by Commissioner Beroukhim and approved unanimously.
