NOTICE IS HEREBY GIVEN that Proposals will be received by the **City of West Hollywood**, as AGENCY, for furnishing all materials, equipment, tools, labor and incidentals as required for the above stated services in strict accordance with the specifications/contract documents on file at the office of the City Clerk of the **City of West Hollywood**.

A mandatory site walk will be held on Wednesday, August 20, 2014 at 9:00 a.m. at 626 N. Robertson Boulevard (Entrance on El Tovar Place). This meeting will allow proposers to review the scope of work and receive answers to any questions. Each prospective proposer is responsible for fully acquainting themself with the conditions of the Project Site. Each and every Proposer MUST attend the Site Walk. Individuals who do not arrive on time for the start of the meeting at 9:00 a.m. may be denied entry and therefore, shall be deemed unable to submit a proposal. Prospective proposers MAY NOT visit the Site other than during the above mentioned site walk.

The intent of the CITY is to hire a firm that has the ability to provide complete construction management services for a project that shall include but is not limited to ADA Accessibility Upgrades, Installation of Elevator with Machine Room and Tennant Improvements to include but

not limited to electrical, mechanical, plumbing upgrades and general building improvements and fire and safety system upgrades.

The City reserves the right to reject any and all Proposals and to award the contract to the Contractor who best meets the requirements set forth in the Specifications/Contract Documents and to take all proposals under advisement for a period of ninety (90) days.

Qualifications of Consultant: Consultant team shall be able to provide construction management services for the scope of work outlined in the Request for Proposal documents.

In accordance with provisions of Section 1773.2 (amended 1977) of the California Labor Code, copies of the prevailing wage rate of per diem wages as determined by the State Director of Industrial Relations available **on online at www.dir.ca.gov**. It shall be mandatory upon the Contractor to whom the contract is awarded and upon any subcontractor under them to pay not less than said specified rates to all workers employed by them in the execution of the contract as applicable. Compliance with the City of West Hollywood Living Wage Ordinance is also required.

The **City of West Hollywood** hereby notifies all proposers that it will affirmatively insure that in any contract entered into pursuant to this advertisement, Disadvantaged Business and Women's Business Enterprises will be afforded full opportunity to submit PROPOSALs in response to this invitation and will not be discriminated against on the grounds of race, creed, color, or national origin in consideration for an award.
