Reviewed and discussed and approved the temporary mural project "Dance of the Butterfiles" by artist Marisabel Bazon for installation on the Modern Rug L.A. building located at 629 La Cienega Blvd for ratification by the Arts and Cultural Affairs Commission. **Motioned by Commissioner Williamson**, seconded by Commissioner Beroukhim and approved unanimously.
- d. Approved arts programming for the August 2014 installation on the Videotron at 9039 Sunset Boulevard featuring images from the "Risk" artist catalog and images from the "Music" catalog and approved the allocation of arts minutes on the videotron for the month of September in conjunction with the SSBA's Sunset Strip Music Festival for ratification by the Arts and Cultural Affairs

Commission. **Motioned by Commissioner Denenberg, seconded by Commissioner Dishman and approved unanimously.**
