Stephanie Harker, resident of West Hollywood, thanked everyone for attending National Night Out and encouraged more crime prevention awareness at the event.

Larry Block, resident of West Hollywood, encouraged the Commission to work more on crosswalks and pedestrian safety.

Heidi Shink, resident of West Hollywood, spoke regarding a new Neighborhood Watch group on the 900 block of Curson and the passing of Robin Williams.

### 8. COMMISSIONER COMMENTS AND LIAISON REPORTS

Commissioner Bazley thanked everyone for their hard work at National Night Out, especially Laura Manukian, residents, local businesses, and event coordinators. Commissioner Bazley encouraged work on crosswalks and pedestrian safety. Commissioner Bazley spoke regarding the recent incidents of police brutality in Los Angeles, New York, and Ferguson, Missouri.

Commissioner Hoffman thanked everyone for their participation and hard work at National Night Out, especially residents, Sheriff's Deputies, and Fire Fighters. Commissioner Hoffman thanked Ms. Shink for creating a new Neighborhood Watch group and encouraged all to attend Neighborhood Watch meetings on their street or start a new group if one does not exist. Commissioner Hoffman spoke regarding the useful information covered at Neighborhood Watch meetings such as crime statistics, safety tips, and other resources.

Commissioner Williams thanked everyone for their participation and hard work at National Night Out. Commissioner Williams spoke regarding the bulky item pick up program by Athens. Commissioner Williams stated that NCJW is hosting a

program on November 12, 2014 regarding senior scams and elder abuse. Commissioner Williams spoke regarding her attendance at the recent Disabilities Advisory Board meeting and a presentation by NCJW. Commissioner Williams said that Public Safety Commissioners will be working with Transportation Commissioners on crosswalk issues.

Commissioner Norton thanked all for their participation and hard work at National Night Out. Commissioner Norton stated that information about the other National Night Out locations could be better publicized. Commissioner Norton spoke regarding her attendance at a recent Senior Advisory Board Meeting at which COPPS Team Deputies gave a presentation regarding senior scams and fraud. Commissioner Norton congratulated Ms. Shink on starting a new Neighborhood Watch meeting. Commissioner Norton expressed frustration with Transportation staff and the lack of information regarding crosswalk updates and the need for better lighting.

Commissioner Clarkin apologized for being a few minutes late. Commissioner Clarkin said that he will be attending the Rent Stabilization Commission meeting on Thursday. Commissioner Clarkin thanked all for their participation and hard work at National Night Out, especially Laura Manukian.

Commissioner Sol thanked the members of the public for their attendance. Commissioner Sol encouraged all to use WeHo Direct for any issues that need immediate response. Commissioner Sol thanked all for their participation and hard work at National Night Out. Commissioner Sol suggested that Laura Manukian attend a future meeting to answer neighborhood watch and crime prevention questions. Commissioner Sol reminded all that there will be several events regarding Day of Remembrance in the month of November hosted by the Transgender Advisory Board.

# 10. REPORT FROM THE FIRE DEPARTMENT

Maria Grycan reviewed the suppression, rescue, and fire prevention activities during the month of July 2014 including inspections, fires, and emergency medical calls.

Commissioner Hoffman inquired about the number of trash fires.

Ms. Grycan and Chief Errett stated that there was no discernable pattern regarding the trash fires.

Commissioner Clarkin asked if fire personnel collaborate on information to determine trends.

Chief Errett said that all West Hollywood personnel examine statistics and collaborate on issues.

Ms. Grycan formally introduced Chief Errett to the Commissioners.

Chief Errett thanked the Commissioners and spoke briefly about his career with the Fire Department and said that he is very happy to be working in West Hollywood.

### 12. REPORT FROM THE SHERIFF'S DEPARTMENT

Lieutenant Smith stated that there were arrests made in the arson trash fires. Lieutenant Smith thanked the Commissioners for their kind comments regarding the Deputies working National Night Out. Lieutenant Smith spoke regarding the COPPS Team's attendance at the Senior Advisory Board. Lieutenant Smith spoke regarding the special traffic enforcement held on August 3, 2014 and said that both cars and pedestrians were cited.

Commissioner Williams encouraged better enforcement of bicyclists ignoring the vehicle code.

Lieutenant Smith spoke regarding a recent incident where a cyclist ran six stop signs before being stopped by Sheriff's personnel.

Lieutenant Smith spoke regarding the recent vehicle vs. pedestrian accident on El Toyar and Robertson.

Lieutenant Smith reviewed the Sheriff's Department statistics for July 2014, including crimes, calls for service, and arrests. Lieutenant Smith spoke regarding improved response times for routine calls for service. Lieutenant Smith spoke regarding a decrease in property crimes. Lieutenant Smith spoke regarding alcohol related assaults and two recent robberies on the east side.

Lieutenant Smith stated that there were 12 DUI arrests and 6 DUI related crashes in the month of July. In addition, there were 5 vehicle vs. pedestrian accidents, 0 vehicle vs. bicycle accidents, and 1 bicycle vs. pedestrian accident.

Commissioner Sol requested that the crash car for Labor Day weekend be more visible and to include one on Sunset Boulevard.

Staff and Lieutenant Smith will work on the crash car locations.

Commissioner Hoffman requested clarification on Grand Theft incidents.

Lieutenant Smith stated that there was a lot of high end shoplifting on the west side in July.

Commissioner Sol thanked Lieutenant Smith for his attendance at the last Walk About with the Captain.

Lieutenant Smith thanked Commissioner Bazley for his concern for police brutality incidents and spoke regarding the training and expectations of West Hollywood personnel.

Lieutenant Smith introduced Phillip Rothschild, Sheriff's Volunteer.

Mr. Rothschild spoke briefly about the Sheriff's Volunteer Program and the many services that the thirty-eight volunteers provide to the West Hollywood Station and to the West Hollywood community.

Commissioner Clarkin spoke regarding the many services that the volunteers provide to the West Hollywood Station and to the West Hollywood community.

Commissioner Hoffman thanked Mr. Rothschild and the volunteers.

Commissioner Sol thanked the Station and the City's Public Information staff for their use of social media.
