

The City of West Hollywood is soliciting bids for the purchase of a 9,350 lbs. minimum gross vehicle weight rating Ram Promaster Full Size High Roof Van.

Sealed bids must be received by the City no later than 3:00 p.m. local time, on Tuesday, December 9, 2014, at the office of the City Clerk of the City of West Hollywood, 8300 Santa Monica Boulevard, West Hollywood, California 90069. On the front of all bids clearly write:

#### **NOTICE TO BIDDERS**

The CITY hereby affirmatively ensures that minority business enterprises will be afforded full opportunity to submit bids in response to this notice and will not be discriminated against on the basis of race, color, national origin, ancestry, sex, or religion in any consideration leading to the award of a contract/agreement.

Bids must be prepared on the approved Bid Forms in conformance with the Instructions to Bidders and Bid Documents, and submitted in a sealed envelope plainly marked on the outside.

The City of West Hollywood reserves the right to reject any and all bids, or to waive irregularities or informalities in the selected bid as may be permitted by law. In addition, the City of West Hollywood reserves the right to reject the bidder who has been delinquent or unfaithful in any former agreement with the City of West Hollywood, should it deem this necessary for the public good. The City of West Hollywood reserves the right to take all bids under advisement for a period of ninety (90) days. No bidder may withdraw their bid for a period of ninety (90) days after the date from the opening thereof. The award of agreement, if made, shall be determined solely by the City of West Hollywood.

Bidders may not take exception to items in these specifications where the term "No exceptions" is specified.

When submitting bids, bidders are required to submit detailed literature and pictures of the vehicle they propose to furnish.

Bids will be considered on vehicles complying substantially with these specifications as determined by the City, provided each deviation is explained in detail and the substitution is described.

The determination of "equal" rests solely with the City. All warranties, expressed or implied, must be submitted in writing and will be evaluated as part of the bidder's formal bid offering.

Delivery time must be submitted in writing and will be evaluated as part of the bidder's formal bid offering.

Bidders are required to state the complete unit price, including sales tax in this bid. Prices quoted shall be F.O.B. West Hollywood, CA.

Failure to adhere to the aforementioned requirements for bid submission may be sufficient cause for rejection of the bid.

#### BID FORMS

Bids shall be submitted in writing on the Bid Forms provided by the CITY. All information requested therein must be clearly and legibly set forth in the manner and form indicated. The CITY will not consider any bid not meeting these requirements.

#### INFORMATION REQUESTED AND NOT FURNISHED

The information requested and the manner of submission is essential to prompt and fair evaluation of all bids. Accordingly, the City reserves the right to declare as non-responsive and reject any bids in which information is requested and is not furnished or when a direct or complete answer is not provided.

#### **BID ERRORS**

Bidder is liable for all errors or omissions incurred in preparing the bid. Bidders will not be allowed to alter bid documents after the due date for submission.

Bidders are hereby notified that the City will rely on the accuracy and completeness of all information provided in making its selection. As such, bidders are urged to carefully review all information provided to ensure the clarity, accuracy and completeness of such information. As the City deems necessary and appropriate in its sole discretion, the City reserves the right to make any inquiries or other follow up required to verify the information provided.

#### **RECEIPT OF EQUAL BIDS**

If two or more bids received are for the same total amount, quality being equal, and if the public interest will not permit the delay of re-advertising for bids, the City Council may accept the bid it chooses or accept the lowest bid made by negotiation with the tie bidders.

#### **DELIVERY OF BID**

Bids shall be enclosed in a sealed envelope, plainly marked on the outside,

Bids may be mailed or delivered by messenger. However, it is the Bidder's responsibility alone to ensure delivery of the bid to the hands of the CITY'S designated official (City Clerk) prior to the bid-opening hour stipulated in the Notice Requesting Sealed Bids. Late Bids will not be considered.

#### WITHDRAWAL OF BID

A bid may be withdrawn by a written request signed by the bidder. Such requests must be delivered to the CITY'S designated official prior to the bid-opening hour stipulated in the Notice Requesting Sealed Bids. No bid may be withdrawn during the period of ninety (90) days after opening of bids.

#### **IRREGULAR BID**

Unauthorized conditions, limitations, or provisions attached to a bid will render it irregular and may cause its rejection. The completed Bid Forms shall be without interlineations, alterations, or erasures. Alternative Bids will not be considered unless specifically requested. No oral, electronic, telegraphic, or telephonic bid modification or withdrawal will be considered.

#### INDEMNIFICATION

Successful bidder and/or agencies participating in this solicitation agree to indemnify, defend and hold harmless the City and their elected and appointed officers, employees, agents and contractors from and against any and all liability and expense, including defense costs and legal fees, arising from or connected with claims and lawsuits for damage relating to the execution of this solicitation, subsequent purchases or contract, or lawsuits and damages relating to the products, equipment and/or vehicles purchased under said agreement.

#### **FORMAL APPROVAL OF CONTRACT**

Acceptance of a bid does not constitute a contract with the City. A contract shall be created only by formal approval by the City Council of West Hollywood and issuance of a purchase order by the City Purchasing Agent.

The City may, at its discretion, reject all bids submitted. Under no circumstances shall the City be liable for any costs incurred in connection with the preparation and submission of any bid.

#### LIQUIDATED DAMAGES

All time limits stated in the purchase order are of the essence. Should the delivery not be completed on or before the time stipulated, it is mutually agreed by and between the successful bidder and the City that:

A delay may seriously affect the public and the operation of the City; that a reduction in the unit price of Fifty Dollars (\$50) per calendar day for each and every day for each unit which exceeds the delivery time set forth in the purchase order is the nearest measure of damages for each delay that can be fixed at this time; therefore, the City and the successful bidder hereby establish said reduction in the unit price of Fifty Dollars (\$50) per calendar day for each and every day of delay for each unit as liquidated damages and not as a penalty or forfeiture for the breach of agreement to complete delivery by the successful bidder on or before the time specified in the purchase order.

Liquidated damages shall not apply to time elapsing between date of delivery and date of notification to the successful bidder or rejection of sub-specification material.

The above conditions may be evoked if deliveries exceed the specified time or if replacement of material not meeting specification exceeds the specified time.

Should the successful bidder be obstructed or delayed in the work required to be done herewith by changes in the work or by default, act, or omission of the City, or by strikes, fires, acts of God, or by the inability to obtain materials, equipment or labor due to federal government restrictions arising out of the defense or war program, then the time of completion shall be extended for such periods as may be agreed upon by the City and the successful bidder.

If there is insufficient time to grant such extensions prior to completion date of the contract, the City may, at the time of acceptance of the work, waive liquidated damages which may have accrued for failure to complete the work on time, due to any of the above, after hearing evidence as to the reasons for such delay and making a finding as to the cause of same.

In the event that the successful bidder is on strike at the time of the award of the bid, the City reserves the option to accept the first acceptable bid from a manufacturer that is not on strike.

#### **COMPLIANCE WITH CODES AND STATUTES**

The vehicles shall conform in every respect with the latest editions of the Motor Vehicle and Administrative Codes and Regulations of the State of California, Federal Motor Vehicle Safety Standards and all applicable provisions of the California Occupational Safety and Health Act.

It is the sole responsibility of the successful bidder to advise the City in writing of any conflicts between the requirements herein and the aforementioned Codes and Standards.

#### **INTENT OF SPECIFICATIONS**

It is the intent of these specifications to obtain vehicles that will meet the rigorous requirements of city emergency support service.

These specifications are intended to describe the type, size and quality of vehicles desired and to cover the furnishing and delivery to the purchaser of complete vehicles equipped as hereinafter specified.

These specifications are intended to describe the City's minimum requirements.

Minor details of construction and materials, where not otherwise specified, are left to the discretion of the manufacturer, who shall be solely responsible for the design and construction of all features.

#### **INFORMATION REQUIRED**

The following shall be furnished with the vehicle, unless noted "total", at the time of delivery, as well as other potentially necessary documents and information:

- 4 Keys
- 1 Operator's Manual
- 1 Warranty Book and/or Card with delayed start warranty, **No Exceptions.**
- 1 Dealer's New Vehicle Report of Sale
- 1 Smog Certificate (if required)
- 1 Invoice for Vehicle Received
- 1 Owner's manual and warranty card for any supplied equipment

State of California "*Exempt*" registration documentation shall be completed by the selling dealer and indicate the legal and registered owner as: CITY OF WEST HOLLYWOOD,

8300 Santa Monica Boulevard, West Hollywood, CA 90069. Failure to provide any of the printed material specified above may be cause for rejection of the vehicle.

#### **GENERAL**

The complete vehicle, including the body, finish, fittings, components and accessories shall be the latest model, shall be new and shall not be used in demonstrator or other service, and shall be factory standard or factory provided in all respects not in conflict with specific requirements.

The design of the vehicles shall be such that it does not hamper or restrict subsequent installation and use of emergency equipment, radios and light bar siren configuration to the satisfaction of the City.

When the specification for particular items is not defined, manufacturer's standards are either satisfactory, or they are not applicable to this vehicle.

All "standard" equipment shall appear on the vehicle as listed or reflected in the manufacturer's applicable sales brochure.

Successful bidder to provide verification of dealer order within fifteen (15) days of receiving purchase order. The verification is to be forwarded to the City's Project Manager.

#### **WARRANTY**

Manufacturer's standard bumper to bumper warranty shall be provided. Three (3) years/36,000 miles minimum.

Manufacturer's standard warranty for drive train shall be provided. Five (5) years / 100,000 miles minimum but shall not reduce any other standard warranty.

The warranty shall begin from the date and odometer reading when the City places the vehicle in active service.

Warranty work will be performed at any dealership convenient to the City.

Use of other than original equipment parts shall not void the warranty.

Routine required service inspections may be performed by City mechanics and/or contractors and shall not void the warranty.

Upfitting, including but not limited to the installation of cabinetry, additional seating, HVAC, AC/DC electrical systems, communications and warning lighting by the City and/or its contractors shall not void the warranty.

#### **DELIVERY**

All vehicles delivered to the City as a result of this solicitation shall be identical in every

respect with the vehicle called for specifically in these specifications unless otherwise noted herein.

All vehicles will have the dealer preparation service work, normally performed by the dealer, completed prior to delivery.

All vehicles will be delivered clean, with fuel tanks **full** and ready for immediate service.

City personnel will inspect all vehicles for compliance with specifications. If defects are found requiring correction, it shall be the dealer's responsibility to return them for correction. All transportation to and from the City Facility will be the responsibility of the vendor until the vehicle or vehicles are accepted. Any vehicle or vehicles not accepted shall be removed immediately from the City Facility at the vendor's expense.

All vehicles shall be delivered to City Hall, 8300 Santa Monica Boulevard, West Hollywood, CA 90069. The City's Project Manager, Bonnie Smith, **shall be notified at** (323) 848-6414, 24 hours prior to delivery, between the hours of 8:00 a.m. and 3:00 p.m. daily, except weekends and holidays. **No exceptions** 

#### **DESCRIPTION OF EQUIPMENT**

These specifications describe (as outlined in the bid documents) a 2014/2015 9,350 lbs. minimum gross vehicle weight rating Ram Promaster Full Size High Roof Van designed for use by City of West Hollywood Public Safety Department.

All equipment supplied under these specifications shall be the manufacturer's latest production model, including all standard equipment and its latest changes, all approved and incorporated field designed and implemented changes, revisions and additions at the time of delivery. All equipment furnished under this contract shall be new, unused and the same as the manufacturer's current production model. Accessories not specifically mentioned herein, but necessary to furnish complete unit ready for use, shall also be included. Unit shall conform to the best practice known to the body trade in design, quality of material and workmanship.

The vendor is expected to obtain all equipment specified herein, combine into a route-ready vehicle, and deliver to the City within 30 business days of the award of the bid by the City or within a timeline mutually agreed on by the City and the bidder.

#### REQUESTS FOR INFORMATION

Any errors, omissions, or discrepancies found in the bid documents shall be called to the attention of the CITY and clarified prior to the submission of bids.

The deadline for Requests for Information (RFI's) is Tuesday, December 2, 2014 at 3:00 p.m. The format is as follows:

1. Contractor to submit all requests for clarification of additional information in writing to the City of West Hollywood's Project Manager Bonnie Smith.

- 2. RFIs shall be numbered sequentially.
- 3. Each RFI shall be limited to one subject.
- 4. An RFI should be submitted if any one of the following occur:
  - Contractor discovers an apparent conflict or discrepancy between portions of the Bid Documents
  - b. Contractor discovers what appears to be an omission from the Bid Documents

#### **PERMITS AND FEES**

The successful bidder shall comply with all applicable federal, state and local requirements. The dealer is responsible for licensing the bid vehicle(s). The vehicle(s) must be delivered with a State of California Department of Motor Vehicles Temporary Identification affixed to the windshield. Exempt license plates shall be delivered to the City within 90 days of vehicle(s) delivery. Any documentation fees must be included in the vehicle(s) bid price.

#### ADDENDUM(S)

The City reserves the right to issue addendum(s) to this NOTICE REQUESTING SEALED BIDS, which may add additional requirements to be considered responsive. All Bidders must acknowledge any addendum(s) issued as a result of any change in this NOTICE REQUESTING SEALED BIDS. Failure to indicate receipt of addendum(s) on acknowledgement form provided with issued addendum(s) may result in a bid being rejected as non-responsive. Whenever possible, all addendum(s) will be issued via email.

#### LAWS AND REGULATIONS

The unit furnished to meet these specifications, including all equipment and accessories, must comply with the current applicable regulations and standards of the California Air Resources Control Board (CARB), OSHA, California-OSHA, ANSI, and all other applicable State or Federal standards and regulations that may apply.

#### **MAINTENANCE**

The City may consider using the successful bidder for maintenance and service, but the City reserves the right to use other companies for maintenance and service for any reason.

#### **BID FORMAT**

The bidder shall submit to the City a sealed, complete bid response package detailing the equipment proposed to meet these specifications. All bidders must use the attached Bid Forms. The standard vendor quotation is not an acceptable substitute for completion of the attached forms. The attached forms must be filled out completely.

#### **DISQUALIFICATION OF BIDDERS**

More than one bid from an individual, firm, partnership, corporation, or association under the same or different names will not be considered. Reasonable grounds for believing that any bidder is interested in more than one bid for the equipment requested will cause the rejection of all bids in which such bidder is interested. If there is reason for believing that collusion exists among the bidders, all bids will be rejected and none of the participants in such collusion will be considered in future bids. No bid will be accepted from a bidder who has not been licensed in accordance with the provisions of the State of California Business and Professions Code and who do not possess the appropriate State of California Business licenses to supply the required equipment under this Notice Requesting Sealed Bids, at the time of bid submittal.

#### COMMUNICATIONS REGARDING THIS NOTICE REQUESTING SEALED BIDS

Communications regarding this NOTICE REQUESTING SEALED BIDS shall be made exclusively with the designated Project Manager named in these instructions. Bidders that contact other City personnel or City Council members after the City releases this NOTICE INVITING BIDS and throughout the evaluation period may be disqualified from consideration. This requirement applies to bidder's representatives, lobbyists and agents. If you feel it is necessary to communicate with someone aside from the designated Project Manager about this process, please do so in writing to the Director of Human Services.

#### **LEGAL RESPONSIBILITIES**

All bids must be submitted, filed, made, and executed in accordance with State and Federal laws relating to bids for agreements of this nature whether the same or expressly referred to herein or not. Any bidder submitting a bid shall by such action thereby agree to each and all of the terms, conditions, provisions, and requirements set forth, contemplated and referred to in the Request for Bids, Instructions to Bidders and Bid Forms to full compliance therewith.

#### PROPERTY OF CITY/PROPRIETARY MATERIAL

All bids submitted in response to this NOTICE REQUESTING SEALED BIDS shall become the property of the City and subject to the State of California Public Records Act. Bidders must identify all copyrighted material, trade secrets or other proprietary information that the bidders claim are exempt from the California Public Records Act (California Government Code Section 6350 et seq.).

In the event a bidder claims such an exemption, the bidder is required to state in the bid the following: "The Bidder will indemnify the City and its officers, employees and agents, and hold them harmless from any claim or liability and defend any action brought against them for their refusal to disclose copyrighted material, trade secrets or other proprietary information to any person making a request thereof."

Failure to include such a statement shall constitute a waiver of a bidder's right to exemption from this disclosure.

#### **COST OF BID SUBMISSION**

The City is not responsible for any costs incurred by bidder while submitting bids. All bidders who respond to solicitations do so solely at their own expense.

#### **BUSINESS LICENSE**

The bidder must have, or obtain a valid license to do business in the City of West Hollywood prior to the issuance of an agreement.

#### **AWARD OF AGREEMENT**

The award of agreement, if made, will be to the lowest responsive and responsible bidder as determined solely by the City of West Hollywood. The award, if made, will be made within ninety (90) days after the opening of the bids, provided that the award may be made after said period if the successful bidder has given the City of West Hollywood written notice of the withdrawal of his /her bid.
