#### ITEMS FROM STAFF

A. Shared Economy Task Force Update from Laura Minnich

Commissioner Warren commented that Uber and Lyft drivers tend to hang out on residential streets and in taxi stands.

Commissioner Greene asked about Access and passengers with disabilities.

Laura Minnich said that the issues were discussed.

Commissioner Greene stated that it really isn't a shared economy since the programs are for profit and there is no sharing involved.

Laura Minnich replied that the description is being changed on the state level.

Commissioner Eichman asked if the expansion of the PickUp Line included identifying parking locations on the eastside.

Laura Minnich said that it had been considered.

Commissioner Walia-Fazio asked how much the expansion would cost.

Laura Minnich said it would be \$400,000 in the 15-16 Fiscal Year. Prop A funds are currently being used. She added that she would provide the Commission with a more detailed accounting for the next Transportation Commission meeting.

Commissioner Walia-Fazio asked if it is budgeted.

Laura Minnich said that it has yet to be approved by the City Council.

Commissioner Walia-Fazio asked if the service is free.

Laura Minnich said it is free and the drivers accept tips.

Commissioner Cooper asked why there was a 7:00 pm cut off on Sunday.

Laura Minnich explained that the operations contractor felt that longer hours would require additional drivers and vehicles.

Commissioner Warren asked how much operations cost for the current program.

Laura Minnich said that it costs \$260,484.

Commissioner Warren asked if there was any long term loss after initial interest.

Laura Minnich said there wasn't.

Commissioner Greene asked if it would cost less after the first year of expansion of services.

Laura Minnich said that it would not and explained the costs.

Commissioner Warren asked why it costs so much to add La Brea.

Laura Minnich explained.

B. Aging in Place Strategic Planning presentation from Perri Sloane Goodman.

Perri Sloane Goodman gave an overview of an initiative being undertaken by the City to develop informed policies to ensure that the City remains safe and comfortable to residents as they age. She asked that a delegate and alternate be designated to represent the Transportation Commission at a policy review to be hosted by the Human services Commission in April or May, 2015.

Commissioner Walia-Fazio was selected as a representative for the Transportation Commission, with Commissioner Cooper as alternate.

C. Mobility Update from Bob Cheung

Commissioner Warren shared concerns about the lighting at crosswalks and asked if it was possible to provide more light than is required.

Bob Cheung said that he would refer the idea to Public Works.

Commissioner Warren suggested setting up cameras of employing someone to watch and identify which vehicles are knocking down inpavement signs at crosswalks.

Bob Cheung replied that the signs are very new to the City and anticipates that the knock-down rate will go down as drivers become aware of them.

Commissioner Warren asked when the next phase of solutions would be implemented.

Bob Cheung gave a timeline.

Commissioner Cooper reported that four residents have said that the in-pavement signs help them slow down.

Bob Cheung replied that staff has received a 50/50 reaction to the signs.

Commissioner Walia-Fazio stated that she has witnessed a few different causes for the signs knocked down and finds them effective. She hopes that they will become permanent.

Commissioner Eichman requested that the Commission be informed of the actual installation dates of devices so that they can be well equipped for public interaction. He asked if staff anticipates any claims against the City for damages incurred in the knocking down of signs.

Bob Cheung said that he does not have enough information to give a definitive answer.
