IV. UNFINISHED BUSINESS

A. Urban Art Subcommittee Report

The Commission received a report from the Urban Art Subcommittee on its meeting held January 15, 2015 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Denenberg reported that the Subcommittee received a presentation from representatives of Combined Kings Road, LLC and art consultant Marc Pally on their proposed artist Darcy Huebler for the new 4-story, 48 unit mixed-use development at 8350 Santa Monica Blvd. The Subcommittee also received a presentation from art consultant Rebecca Ansert on Stage III Final Art Plan by artist Susan Narduli for the Urban Art Project at 826 N. Kings Road in addition to an update from staff on Urban Art Projects.

ACTION:

- 1. Approve Stage I Artist Approval of Darcy Huebler for the Urban Art Project at 8350 Santa Monica Boulevard as recommended the Urban Art Subcommittee and in accordance with the City's Urban Art Policy and Guidelines. **Motion by Commissioner Beroukhim, seconded by Commissioner Mays and approved unanimously.**
- 2. Approve Stage III Final Art Plan by Susan Narduli for the Urban Art Project at 826 Kings Road as recommended by the Urban Art Subcommittee and in accordance with the City's Urban Art Policy and Guidelines. **Motion by Commissioner Mays, seconded by Commissioner Beroukhim and approved unanimously.**

B. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held January 22, 2015 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Mays reported that the Subcommittee:

- A. Reviewed a Temporary Art Project Proposal submitted by LA><Art to install the three-dimensional sculpture *Totem (Eleven Holes)* by artist Lisa Williamson in a contemplative park environment at no fiscal impact to the City.
- B. Received a presentation from Andy and JoAnne Goodman, Curators, CBS Outdoor and approved for ratification by the Commission arts programming on the electronic billboard at 9039 Sunset Boulevard by artists Kyle Baker, Blade, Massenburg, Overton Loyd, Arcelia Pockman and Wane for the February 2015 (African American Heritage Month) installation.
- C. Approved for ratification by the Commission "Dancers We Lost to AIDS" project on the electronic billboard in conjunction with the "Art AIDS America" project.
- D. Discussed the potential purchase of the sculpture project *Three Horned Beast* [and *Baby Beast*] by artists/architects Lisa Little and Emily White. It was the consensus of the Subcommittee to refer this item to the Urban Art Subcommittee for its consideration and recommendation.
- E. Received an update from Public Art Consultant Rebecca Eheman on potential artists and Art on the Outside projects for 2015-16 as detailed in the documents provided by Ms. Eheman.

ACTION:

- 1. Approve arts programming on the Electronic Billboard at 9039 Sunset Boulevard for the February 2015 (African American Heritage Month) featuring artists Kyle Baker, Blade, Massenburg, Overton Loyd, Arcelia Pockman and Wane noting the exclusion of images that could be perceived as controversial or as a commentary on behalf of the City. Motioned by Commissioner Mays, seconded by Commissioner Dishman and approved unanimously.
- 2. Approve the "Dancers We Lost to AIDS" project as part of arts programming on the electronic billboard in conjunction with the "Art AIDS America" project.

 Motioned by Commissioner Dishman, seconded by Commissioner Denenberg and approved unanimously.

C. Art/AIDS/America

The Commission received an update from staff on the Art/AIDS/America Project.

Cultural Affairs Administrator Andrew Campbell commented Museum of Contemporary Arts at the Pacific Design Center (MOCA-PDC) has withdrawn its

participation in the exhibit "Art AIDS America." However, MOCA is considering the possibility of curating an exhibit focused on AIDS from its permanent collection. Staff is in the process of working on corresponding art components around Art AIDS America.

ACTION: Receive and file.
