The City of West Hollywood (CITY) is seeking a qualified firm to provide Landscape Architect Project Services on an on-call basis as needed with a strong emphasis on water conservation. Minimum Qualifications

Contractor must be a responsible firm that has been in continuous existence and has provided continuous services for the relevant requirements contained herein for at least five (5) years. Less than the minimum required experience will eliminate that proposer from further consideration.

Contractor must have the staffing resources to provide the landscape architectural services required for the scope of work outlined in the specifications.

Contractor shall hold a valid professional license to practice landscape architecture in the State of California in accordance with the State of California Section 5615 of the Business and Professions Code. In addition, all professional staff and sub-contractors shall be appropriately licensed be in the State of California.

Contractor must have municipal community engagement experience.

- Approach and Understanding of the Scope of Work
- Cost of Services

No proposer may withdraw its proposal for a period of ninety (90) days after the date from the opening thereof. The award of contract, if made, will be in accordance with the evaluation criteria provided in the specifications.
