7. OLD BUSINESS

A. Parking Meter Occupancy And Parking Credits Update

Update from Jackie Rocco, Mott Smith and Jeff Jacobberger

Commissioner Walia Fazio asked about parking spaces in the Pacific Design Center.

Mott Smith said that there were 400 spaces, but they are not utilized.

Commissioner Walia Fazio asked how the public would know that there is parking in the Pacific Design Center.

Jackie Rocco said that there is signage, but visibility could be improved.

Commissioner Doebler asked how much it costs to park at the Pacific Design Center.

Jeff Jacobberger said that it costs ten dollars, but people seem to be reluctant to park in large structures.

Commissioner Warren asked if the Red Building entrance would be opened.

Jackie Rocco said that it would be as the building becomes occupied.

Commissioner Warren asked about the status of way finding.

Jackie Rocco replied that staff is working on it.

Commissioner Warren asked about long term parking.

Jeff Jacobberger explained.

Commissioner Warren asked about daytime parking in West Hollywood parking structures.

Jackie Rocco said that it is basically consistent with meter usage.

Commissioner Wayland asked how the parking requirement compares with occupancy.

Mott Smith explained.

Commissioner Doebler asked if the reduction in citations in residential areas could be because of a change in enforcement.

Jackie Rocco said that there has been no change in enforcement.

Commissioner Doebler asked if meter violations have increased.

Jackie Rocco said that violations have decreased, especially with credit card meters.

Commissioner Warren asked which areas saw larger declines in citations.

Jackie Rocco said it was parking district 5 and mid-city.

Stephanie Harker, WEST HOLLYWOOD, asked questions regarding the update.

Jackie Rocco clarified the extended hours for eastside meters.

Commissioner Doebler asked about areas on the west side that weren't observed, specifically Robertson south of Dorrington.

Jackie Rocco explained that employees park there because of lower utilization.

Commissioner Warren acknowledged Richard Giesbret's email. He said that the one hour free parking at parking structures should be more known. He also stated that it is important to include daytime numbers when evaluating parking credits. He asked to see numbers for the east side. He also asked what it would take for free parking on Sunday.

Mott Smith replied that Sunday is becoming a regular day.

Commissioner Warren asked what the next parking credits district would be.

Jackie Rocco said it would probably be mid-city, depending on participation from private owners.

Commissioner Wayland remarked that it is nice to get positive data.

Commissioner Doebler asked if the post office parking is counted as private.

Jackie Rocco said that it is public, but it is temporary.

Commissioner Doebler asked if it would be folded into the parking credits pool.

Jackie Rocco replied that it has yet to be determined.

Commissioner Cooper greed that the program is great.
