# MINUTES FEBRUARY 14, 1996 WEST HOLLYWOOD CITY HALL 8300 SANTA MONICA BOULEVARD COMMUNITY CONFERENCE ROOM

- 1. CALL TO ORDER: The meeting was called to order at 6:10 p.m.

# 4. APPROVAL OF MINUTES:

# 5. CITIZENS COMMENTS:

TIPPEY KELLEY, WEST HOLLYWOOD, commented on the urgency about re-contractual situations coming up in July 1996. She suggested a sub-committee should go in-depth to see how much it is going to cost and how much could be saved. She also commented on the traffic signal times, stating extra time should be allowed for the disabled and elderly to get across the street and the handicap entrances to the sidewalks need to be more accessible.

COLLEEN WALSH, WEST HOLLYWOOD requested information on requesting disabled parking space in front of a private residence.

MICHAEL AUSTIN, WEST HOLLYWOOD commented on the West Hollywood World Wide Home Page relative to budget and services for people with disabilities. He could not easily find

information regarding disability services and suggested the Disability Advisory Council get more involved in supplementing the West Hollywood World Wide Home Page with resources, E-Mail etc.

## 6. STAFF COMMENTS AND PRESENTATIONS:

A. JODI CURLEE, SOCIAL SERVICES ADMINISTRATOR, commented on community outreach; she suggested taking a closer look at identifying other disabled members in the community, in terms of accessing services and getting people involved. She had a meeting with Member Taylor to discuss a retreat for the Disabilities Advisory Members and he felt that it would be helpful to bring somebody in to do disability training. Member Taylor requested discussion about the Housing Corporation and some type of survey which would include a needs assessment and satisfaction with services survey.

## 9. DISABILITIES ADVISORY MEMBER COMMENTS:

Member Enokian commented on "curb cutouts".

Member Hamlett suggested focusing on our community base and not get too involved with county, state or federal issues. He also suggested advocacy and more presentations on special events.

Member Von Douris indicated he would like to see future meetings dealing with sub-committees, ADA compliance, employment, Rent Stabilization, access housing, community services, transportation and the West Hollywood Advisory Council awards dinner. He also requested that Community Development be brought back for further

discussions; the banking commission be brought in; an ordinance be developed by the City Attorney for off-street, residential and business parking and discussions be held regarding the MTA and bus passes for the disabled.

Ex-Officio member Mackler indicated he would like to see better public relations and some type of campaign in regards to what type of services are offered to the disabled. He also suggested an advocacy program relative to government services.

Assistant City Manager Makinney suggested a presentation about the Brown Act and additional discussions on blue curbing, City facility accessibility, City meeting accommodations, transportation options and affordable housing for disabled persons.

Member Barrios also would like to see an advocacy program developed for people who are disabled in receiving their city rights, re: tenant rights, etc.

Member Vega suggested calling the Transportation Department to request a ride to the Disability Advisory Council meetings.

In response to an inquiry from Member Von Douris, Assistant City Manager Makinney stated he will submit a request for funds for the Disabilities Advisory Council in the next budget.

## 10. DEVELOPMENT OF NEXT AGENDA:

By consensus, the Advisory Members agreed to hear more on the following:
