# WEST HOLLYWOOD DISABILITIES ADVISORY BOARD MINUTES MARCH 10, 1999

- 1. CALL TO ORDER: Vice Chair Von Douris called the meeting to order at 5:40 P.M.
- 2. PLEDGE OF ALLEGIANCE: Member Aizenman led the Pledge.

#### 3. ROLL CALL:

## 4. APPROVAL OF MINUTES:

ACTIONS: Approve the Minutes of February 10, 1999 as amended with Chair Hallenberg's correct name spelling. Motion by Member Pavich and seconded by Vice-Chair Von Douris and unanimously carried.

#### 5. PUBLIC COMMENT:

HAL MILLER stated that the proposed Restroom Ordinance should be amended with a dollar amount for liability if restroom facilities are denied to the disabled.

## 6. STAFF COMMENTS AND PRESENTATIONS:

SUZANNE DIETRICH, WEST HOLLYWOOD is happy to see that the City of West Hollywood has a Disabilities Advisory Board and wanted to thank the Disabilities Advisory Board members for bringing the

Santa Monica Boulevard tree issue to the attention of the disabled community.

Staff Liaison Jacobs gave an update on the swimming program. As of this date, there have been no inquiries to the program and encouraged everyone to get the word out. He also stated the Santa Monica Boulevard construction office would be opening up next month, just up the block from City Hall and the restroom facilities need to be brought up to ADA compliance before it opened.

Staff Liaison Springer gave an update on what will be appearing on the April 14<sup>th</sup> Disabilities Advisory Board Agenda.

#### 7. UNFINISHED BUSINESS:

# A. RECENT CHANGES IN RENT STABILIZATION LETTER.

The Disabilities Advisory Board heard from Hal Cronkite, Director of Rent Stabilization on the draft letter with amendments regarding the effects of recent changes in Rent Stabilization; specifically on Section 8 Housing on the disabled community.

Mr. Cronkite took various questions from the Disabilities Advisory Board Members and responded.

Rent Stabilization Rent Counselor John Berndt was introduced and he explained the Section 8 Housing program in explicit detail within the City of West Hollywood.

A motion was made to withdraw the letter that was approved at the last meeting on Rent Stabilization issues. Motion by Member Weltman, seconded by Member Cislowski. And unanimously carried.

#### B. PUBLIC FORUM.

The Disabilities Advisory Board discussed the pros and cons of having a Public Forum on disability issues.

Staff Liaison Springer suggested a televised forum rather than a public forum due to attendance problems that have been experienced in the past.

Chair Hallenberg suggested forming a sub-committee with Member Weltman to Chair, along with Members Aizenman, Ciszlowski and Semonco to serve on the sub-committee. This item will be brought back in a report to the Disabilities Advisory Board at the May, 1999 meeting.

#### 8. **NEW BUSINESS:**

#### A. PROPOSED ORDINANCE OF RESTROOM FACILITIES.

The Disabilities Advisory Board discussed the proposed Ordinance of the City of West Hollywood which makes available restroom facilities for persons with physical handicaps regardless if they are a customer, client, employee or paid entrant.

Motion by Member Weltman that City Council adopt this Ordinance with amendments. There was no second motion. This motion did not pass.

Motion by Member Cislowski for the City Council to adopt the Ordinance in its current form as written. Seconded by Member Semonco.

SUZANNE DIETRICH, WEST HOLLYWOOD stated that the disabled community feels that they are not being recognized and that they are overlooked in the City of West Hollywood. They feel they are being lumped together with the senior citizens and feels that if you start to recognize the disabled community separate from the senior citizens, that you might gain more support.
