A. CENTURY CABLE TELEVISION
(Helen Goss, Public Information Officer/CATV Manager)

Co-Liason Reynolds announced that Helen Goss was unable to attend due to the Budget Community Forums that requires her attendance, but stated that she will be attending the meeting in April.

Reynolds stated that Goss will be forming a sub-committee to work on the Cable Franchise Agreement and will be seeking volunteers.

#### A. PUBLIC FORUM

(Irving Harrison, DAC Member) (Kathryn Reynolds & Tamar Springer)

Various and numerous items and concerns were voiced during this Item; including transportation issues; to and from the Public Forum, speakers (which staff was directed to research), location, publicity, the senior community, items of discussion, refreshments, time and date and the following the action taken:

A unanimous suggestion was recommended that the Public Forum be held at West Hollywood Park on a tentative date of Sunday, July 13, 1997 between the hours of 3 p.m. to 6 p.m.

#### 9. DISABILITIES ADVISORY COUNCILMEMBER COMMENTS:

Member Harrison had 3 suggestions:

- more painted cross-walks
- walk signals should be extended by at least 10-15 seconds
- Council meetings have sign interpreters on televised Council Meetings

A discussion took place regarding sign language and closed captioning.

Member Kelley requested specifically that a painted crosswalk be installed at Santa Monica Boulevard and Harper.

Member Gradinger reminded DAC members that "Councilmember Comments" are strictly for discussion, no action can be taken under this Agenda Item.

Member Von Douris suggested that the DAC Meetings meet for at least 1 hour, 45 minutes and also recommended a retreat once a year.

Co-Liason Springer will check into the By-Laws of the Disabilities Advisory Council on the specific time restraints for this Commission and check with other staff regarding a retreat.

Member Siegel commented he would like to see an Agenda Item in the future on ADA Compliance, and would like to know what is being done in the community.

Springer suggested that DAC Members bring in written concerns at the April, 1997 meeting regarding the ADA, which will then give staff time to construct a report.

Von Douris stated that if DAC is going to comply with ADA that sub-committees be set-up and that DAC members be a part of the process.

Chair Enokian stated that he made a brief statement at Abbe Land's going away party.
