The committee commented on the February session focusing on Deafness and Hard of Hearing issues. The consensus was that the constituents present at the meeting represented only a limited segment of the population. Additional means to access the Deaf Community would be explored in the future.

#### V. NEW BUSINESS:

Dee Hays reported that she had voiced the committee's concerns about the availability of accessible affordable housing, in West Hollywood, to the West Hollywood Community Housing Corporation. The W.H.C.H.C. informed Ms. Hays that they would attempt to make contact with Gregg to provide information on what has been, and will be, done to provide housing.

Bill Stirrup informed the committee of an Access Expo that will be held the first weekend of May. Mr. Stirrup plans to attend and will share any information at the next meeting.

#### VII. PUBLIC COMMENT:

The Following issues were raised by the constituents present during the public comments session:

- The CityLine does not have a structured route schedule and as a result it is difficult to plan trips. The result of this causes riders to wait for long periods of time at designated stops. Also, riders needing return trips late in the day may be left without accessible transportation because the van has stopped operation for the day.
- Comments about accessible service on R.T.D. were voiced. Specific issues were the lack of disabled seating and drivers' lack of assistance with lowering steps. However, the issues were beyond the committee's control.
- The constituents present requested that consideration to reduce recreation fees for City sponsored classes and activities be given to persons with disabilities. Currently, Seniors are given a 50% reduction, and this should be considered for the disabled populations also on fixed incomes.
- Safety issues were of concern for the constituents present. The primary issue centered on pedestrian safety. Several crosswalks on Santa Monica Boulevard present hazards, i.e. Plummer Park. Consideration should be given to installation of a signal or caution light. Although there was not a consensus, audible crossing signals would be appropriate at key intersections. The City of Santa Monica was cited as an example of audible signals. Some crosswalks along Santa Monica Blvd. do not have appropriate curb cuts, i.e. Santa Monica/Cresent Hights, Santa Monica median at Westbourne. Additional curb cuts throughout the City were damaged during the recent rainy season; asphalt was eroded by water.
- A request was made to increase the size of lettering on signage at City Hall. This will allow greater accessibility/independence for persons with mobility/visual impairments.
- A suggestion was made for an update to the "Access Guide" publishing locations of accessible businesses, entertainment centers, restaurants and public accommodations.
