CALL TO ORDER: Chair Weltman called the Meeting to order at 5:44 PM.

APPROVAL OF AGENDA:

PUBLIC COMMENT:

ALAN WEBER, WEST HOLLYWOOD, provided information regarding the difference between "hands-on" and "hands-free" use of cell phones while driving. He also stated that the Lesbian & Gay Advisory Board will be hosting an event on September 22 for couples

who have been together 10 or more years and he volunteered to take a list to them if the board had any names they would like to submit.

STAFF COMMENTS:

TAMAR SPRINGER, Staff Liaison, started the process for ordering business cards for the Board Members and she confirmed that there was a sign posted regarding the accessible path located in the back of the new Comprehensive Center.

SUB-COMMITTEE REPORTS:

Legislative – Board Member Weltman reported on the Patient's Bill of Rights which passed in the Senate. The Bill is now in the House of Representatives where it will likely be amended.

Accessibility – Board Member Ahern attended the Abilities Expo and recommended "Extreme Medical" for a sport Expo during Disabilities Awareness Month. He also proposed having an awards ceremony, having the Disabilities Advisory Board meeting televised, a football game, and a "Wheelchair Challenge" for a day. She commented on the countdown crosswalk at Santa Monica Blvd. and Fairfax and the ones soon to be installed with the chirping sound for the visually impaired.
