Michael Wojtkielewicz, a West Hollywood resident, raised several suggestions for future Health Screenings. He also presented a petition to staff regarding removal of AT&T towers on the Sierra Bonita Apartments.

# A. UPDATE ON THE WERLE BUILDING

Steve Campbell, Public Facilities manager, and architect Gene Diep, gave an update on the work to make the Werle Building accessible, and fielded questions from the Board.

### B. EVALUATION OF THE OCTOBER TELEVISED MEETING

Everyone thought the meeting was excellent, and several suggestions were made to make next year's even better, including to have a pre-meeting reception so the Board can meet the award winners, and to shorten the agenda. The staff reported that through various forms of outreach including social media, 46,000 people were informed of the meeting.

The free health screenings were a big success as well, with 170 blood tests, 98 flu shots, 60 stroke screenings, 15 breast risk assessments, 14 HIV tests, and 4 pneumococcal shots.

A motion was made by Advisory Board Member Smith and seconded by Advisory Board Member Dietrich to form the Disabilities Month subcommittee which will include Michael Arrigo, Suzanne Dietrich, Anny Semonco and Louise Smith.

Another motion was made by Advisory Board member Block and seconded by Advisory Board member Colantonio to form an ad hoc committee to plan the Board's participation in ADA25 and the Special Olympics which will include Marco Colantonio, Suzanne Dietrich, Yola Dore, and Rick Watts.

### 9. ITEMS FROM STAFF

In response to concerns about disability signage, Staff Liaison Derek Murray shared photos of signage in West Hollywood Library, the Council Chambers, and the Skyroom. A Board member requested information on signage at Plummer Park.

He also reported on the opening of the Janet Witkin Center at 937 Fairfax with 17 units, including 6 for the homeless and 11 by lottery.

Staff Liaison Corri Planck went over the work plan with the Board.
