WEST HOLLYWOOD HUMAN SERVICES COMMISSION MINUTES - JULY 17, 1996 COMMUNITY CONFERENCE ROOM

I. CALL TO ORDER

II. ITEMS FROM THE PUBLIC

III. <u>UNFINISHED BUSINESS</u>

A. Social Services Contract Program Recommendations for 1996-98 - Discussion of AIDS Education Funding Proposals

Jodi Curlee gave an update regarding the AIDS Education funding proposals that were submitted by AIDS Project Los Angeles, The CORE Program, Gay and Lesbian Center/West Hollywood CARES, Los Angeles Free Clinic/Project ABLE and The Los Angeles Shanti Foundation. She reiterated that staff's recommendation was to fund the Gay and Lesbian Center/West Hollywood CARES program for the full \$69,168 earmarked for AIDS Education.

The public hearing was opened and the following speakers spoke:

Ralph Mayo, West Hollywood - Ralph is the Executive Director of The CORE Program. He discussed the new AIDS Education program that they are proposing to the City and encouraged the Human Services Commission to consider the additional funding for this program.

Joe Morris, West Hollywood - Joe is a resident of West Hollywood. He spoke in support of West Hollywood CARES and encouraged the Human Services Commission to support the funding of their proposed AIDS Education program.

Stephanie Farrington-Domingue, Los Angeles - Stephanie is the director of the Community Outreach and Education program at the Gay and Lesbian Community Services Center. She spoke in support of the West Hollywood CARES program and discussed working in partnership with the City of West Hollywood.

Dean Decent, Los Angeles - Dean works for the Los Angeles County HIV Epidemiology Office. Dean said that he is involved with the "Young Men's Survey" project and has been working closely with West Hollywood CARES. He spoke in support of the CARES program.

Thomas Dyer, Los Angeles - Thomas is the Program Manager for the West Hollywood CARES Program. Thomas spoke on behalf of the program, thanked City staff for their support and encouraged the Human Services Commission to support funding West Hollywood CARES' new AIDS Education proposal.

John Copeland, Los Angeles - John works for the L.A. Shanti Foundation. He encouraged the Human Services Commission to support innovative AIDS Education programs including the proposal from Shanti.

Torr Melling, West Hollywood - Torr is a resident and business owner in West Hollywood. He enouraged the Human Services Commission to support the funding of the proposed AIDS Education program from West Hollywood CARES.

Cheryl Kono, Los Angeles - Cheryl runs the Project ABLE program at the Los Angeles Free Clinic. She spoke on behalf of the program and encouraged the Human Services Commission to consider funding Project ABLE.

Jeff Bailey, Los Angeles - Jeff is the Program Manager for the Sex Essentials program at AIDS Project Los Angeles. Jeff discussed this program and encouraged the Human Services Commission to consider funding Sex Essentials.

The public hearing was closed and the Commission engaged in a lengthy discussion regarding the funding of AIDS Education program(s).

Jodi Curlee clarified that the Social Services staff is interested in supporting the LA Free Clinic's Project ABLE but that the scope of the project in West Hollywood appears to be small enough that we might be able help them out through other means outside the social services contract funding process.

The following motions were made regarding AIDS Education funding:

1. The Human Services Commission moves to support staff's recommendation regarding AIDS Education programs (to fund GLCSC-West Hollywood CARES for \$69,168) and to restore the \$3,636 to L.A. Shanti Foundation for the 1996-98 contract funding cycle.
