Boardmember Moore made a motion to recommend that the City Council support the Pay Check Fairness Act (SB 862/HR 1619); 21<sup>st</sup> Century Women's Health Act of 2015 (SB 674); Equal Protection for All Families Act (AB 960); Tenancy: Termination: Victims of Violent Crimes (AB 418); and STEM Gateways Act (HR 840) and Boardmember D'Amico seconded the motion. The motion was approved by consensus with Boardmember Alexander abstaining.
