I. CALL TO ORDER

II. APPROVAL OF THE MINUTES

Minutes of July 26, 2006: Stephanie Middler made a motion to approve the Minutes, seconded by Rae Mitchell, the motion passed unanimously.

III. ITEMS FROM THE PUBLIC

Nicole Curran, representing the L.I.F.E. program, spoke about their new program focusing on disaster preparedness. She invited the Board to attend an event they are sponsoring for National Preparedness Month on September 27th.

IV. West Hollywood Community Needs Assessment Update
Daphne Dennis, Social Service Administrator for the City, gave a
presentation to the Board about the update report. Highlights
included, She gave specific information about women in the City.
Suggested working with the Board to develop a monograph that
incapsulates information about women.

V. UNFINISHED BUSINESS A. BOARD RETREAT FOLLOW-UP

Staff facilitated a discussion the why members joined, the purpose of the Women's Advisory Board, and who the Board should be trying to reach and ways to do it. (Summary Notes attached)

B. Subcommittee Reports

- 1. Status of Women in West Hollywood Madeleine Rackley reported that the Subcommittee had two meetings since last month. The Subcommittee is seeking input regarding the direction of their work. They raised concerns about duplicating the work of the City's Needs Assessment. Should they continue with the report using data from the needs assessment or focus on analyzing the data and making recommendations about programming or work on both. The Board agreed by consensus to direct the subcommittee to continue to develop a report on the status of women in West Hollywood, reaffiring that this report would incorporate information beyond the statistical data generated by the City's Needs Assessment, such as information about women who work in the City, women in leadership, women business owners, etc.
- 2. 40th Anniversary of the National Organization for Women-Jessie Raeder reported. The Subcommittee has meet twice since last month and made recommendations to the Board regarding ways to commemorate the 40th Anniversary of NOW:

The Subcommittee proposed to integrate the commemoration into the Board's Annual programming for Women's History Month, such as a commemorative Now Banner, donating the proceeds from the Women In Leadership Awards to NOW, (targeting a specific fund such as one to develop young feminists), and to incorporate the history of NOW into the lobby display. Marcy Norton made a motion to endorse the recommendations of the subcommittee. The motion was seconded by Stephanie Middler and passed unanimously.

Staff was directed to ask the Mayor' Office about hosting a Human Rights Speakers Series relating to NOW during Women's History Month.

Lisa Belsanti announced that MOCA @ the PDC and NOW are hosting an event for the book fair, honoring women authors and has asked the WAB to co-sponsor. Marcy Norton made a motion for the WAB to co-sponsor the NOW Reception. The motion was seconded by Rae Mitchell and passed unanimously.

- C. Women's Equality Day, Saturday, August 26th
 Lisa Belsanti updated the Board on the City's Pro Choice City
 Campaign. The kick-off scheduled for August 28th has been
 cancelled.
- D. California Commission on the Status of Women Hearings
 Boardmembers discussed participating in Commission hearings about
 the status of women and girls in California scheduled for September
 20, 2006. Individual members expressed interest in attending or
 submitting written testimony. Madeleine will be attending, Lyndia and
 Kelly are planning to submit written testimony. Lisa Belsanti stated
 that she and Councilmember Abbe Land will be attending on behalf of
 the City.
